RESOLUTION NO. 09-2021 OF THE CITY OF LAKE WORTH BEACH, FLORIDA, APPROVING THE SUBMISSION OF AN APPLICATION FOR FUNDING UNDER THE FISCAL YEAR 2021-2022 LIBRARY SERVICES AND TECHNOLOGY ACT (LSTA) GRANT PROGRAM IN THE AMOUNT OF \$29,600; AUTHORIZING THE MAYOR TO EXECUTE GRANT APPLICATION AND THE REQUISITE CERTIFICATIONS FOR THE FUNDING APPLIATION; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, grant funding under the Library Services and technology Act (LSTA) is provided to public libraries for the purpose of improving literacy rates for residents of the communities they serve; and

WHEREAS, grant funds made available to eligible grantees under the Program to supplement the operating budgets of eligible public libraries to develop literacy campaigns vital to increasing literacy rates among residents to the community; and

WHEREAS, the City of Lake Worth Beach ("City") intends to submit an application to LSTA for funding assistance in the amount of \$29,600 to develop its Literacy City Campaign to increase fundamental and cultural literacy in the City; and

WHEREAS, the City will provide a matching cost share in the amount of \$31,870 that exceeds a the required minimum of one-third of these Program grant funds; and

WHEREAS, these grant funds will serve a valid public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF LAKE WORTH BEACH, FLORIDA, that:

<u>SECTION 1</u>: The City Commission of the City of Lake Worth Beach, Florida, hereby approves the submission of an application for funding under the Library Services and Technology Act (LSTA) for \$29,600 in FY 2021-2022 grant funding to develop the Literacy City Campaign to increase literacy in the City and authorizes the Mayor to execute the Grant application.

<u>SECTION 2</u>: The City Commission of the City of Lake Worth Beach, Florida, hereby authorizes the Mayor to execute all requisite certifications for the City's funding application.

<u>SECTION 3</u>: Upon execution of the resolution, one copy shall be forwarded to the Leisure Services Department Director. The fully executed original shall be maintained by the City Clerk as a public record of the City.

<u>SECTION 4:</u> This resolution shall become effective upon adoption.
