Why? Because Three is now a Par 3, and Four is still a Par 3, and Par 3s are notorious for causing bottlenecks in the flow of play. The gap once afforded by Three's expansive and long fairway used to allow golfers at the tee to send their ball and move forward, but now it's a lot of waiting for putters to abandon the green; combine this for two holes in a row, and at the very beginning of a round, no seasonal golfer in their right mind would think of returning for a round at Lake Worth! It's already enough that the conditions of the bunkers are fair to middling and the water just about reaches your ankles on king tides, but having a paltry Par 3—on what was once the area's "True Test of Golf"—blocking up the flow of traffic would be the straw breaking a camel's back. Without the distance of this Par 4, the course falls into "executive" territory, which isn't where dollars will be spent by those visiting us from up north when they book through vendors like Golf Now and see a sub-6,000 yards on offer. It's why most golfers would rather brave the mid of Lake Worth over the shortness of Poinciana, right up the road and with glowing turf reviews.
