TITLE:

Resolution No. 45-2025 – Fiscal Year 2025-2026 Community Development Block Grant Agreement for improvements to the Wimbley Gymnasium

SUMMARY:

The resolution approves and authorizes the Mayor, or her designee, to execute the Capital Improvements Agreement between Palm Beach County and the City that sets forth the terms and conditions for the use of \$357,312 in Fiscal Year 2025-2026 Community Development Block Grant funds for improvements to the Wimbley Gymnasium. These Community Development Block Grant funds have been made available by Palm Beach County as a "Special Area of Hope" allocation

BACKGROUND AND JUSTIFICATION:

Pursuant to public comment and discussion at the Regular City Commission meeting on March 4, 2025, the City Commission approved the City's proposed use of its Fiscal Year 2025-2026 Community Development Block Grant (CDBG) funding for capital improvements to the Wimbley Gymnasium. Planned improvements include upgrading the signage and marquee, updating the HVAC systems, improving the restroom facilities, upgrading the front entrance, and upgrades to the athletic equipment.

Resolution No. 45-2025 approves and authorizes the Mayor, or her designee, to execute the CDBG Capital Improvements Agreement between Palm Beach County and the City for this purpose. The Agreement sets forth the terms and conditions for the use of CDBG funding in the amount of \$357,312 as determined by dual statutory funding by the U.S. Department of Housing and Urban Development for Fiscal Year 2025-2026. The period of performance to complete these improvements is October 1, 2025, through and including December 31, 2026. The project has been included in the City's Capital Improvement Plan budget.

Public facilities and improvements are eligible CDBG activities. The service area of this public facility is located within the Lake Worth Beach CDBG Target Area, thereby providing a presumed benefit to low-and moderate-income persons.
