MINUTES CITY OF LAKE WORTH BEACH SPECIAL CITY COMMISSION MEETING – PBSO PRIORITIES & CHARTER AMENDMENTS

A. Discussion regarding prioritizing issues for PBSO

Priorities mentioned from the dais were:

Vice Mayor Malega, District 1

• Develop a plan to protect youth during PBSO immigration enforcement activities, which could include requiring a Department of Children & Families representative to be present, assisting parents with guardianship paperwork, issuing identification for school-age children, and coordinating with embassies to inform citizens of their rights.

Commissioner McVoy, District 2:

• Maintain community-wide protection against part 1 crimes.

Commissioner May, District 3

- Submit a report presenting the statistical data on individuals encountered by PBSO during immigration enforcement activities.
- More proactive policing like increased foot patrols in the downtown area.
- Enforcement of quality-of-life regulations as specified in the city ordinances.

Commissioner Segrich, District 4

- Enhanced engagement between officers and the community.
- Implement more proactive policing strategies, such as increased foot patrols throughout the city.
- Maintenance of enforcement on issues like the unlicensed vendors.
