TITLE:

Agreement with Breakpoint Surveying and Underground for Underground Utility Location Services

SUMMARY:

This Agreement authorizes Digital Concrete Imaging, Inc. (dba Breakpoint Surveying and Underground) to provide Underground Utility Location Services for a cost not to exceed \$200,000.

BACKGROUND AND JUSTIFICATION:

The City's Water and Electric Utilities Departments urgently required Underground Utility Location Services after the expiration of a previous agreement. The City Manager has granted emergency authorization to utilize the Orlando Utilities Commission (OUC) Contract for Underground Utility Location Services with Breakpoint Surveying and Underground, and the City seeks ratification of this Agreement. OUC put a request for proposal out for Underground Utility Location Services under Solicitation #24 PR 7847. After evaluation, the contract was awarded to Breakpoint Surveying and Underground which is valid until December 15, 2027. The City desires to piggyback the OUC Agreement including all pricing, terms and conditions for an initial term of six (6) months with the option to extend until the expiration of the OUC Contract. The City's Procurement Policy and Code authorizes the purchases of goods and services through "piggybacking" other governmental competitively procured contracts.
