Methods:	Methods: We collect quantitative information to be analyzed via descriptive statistics. This includes rates of class promotion, graduation rates, and involvement with the Juvenile Justice System. Achievement is measured using the following methods: • Academic outcomes are gathered directly from schools via report cards, progress reports, standardized testing scores, and high school diplomas. • JJIS face-sheet data is received from DJJ. Post-graduation success, internships, and employment placement use both quantitative and qualitative methods, including: • Interviews, placement logs, pre-posttest scores, youth essays, and school reports.			
Outcomes:	Outcomes From October 2024 through September 2025, the program achieved all of six outcomes: • All program participants demonstrate improvement in student academics; • All program participants advanced to the next grade level or graduated on time; • Targeted participants attained post-graduate success; • All program participants remained crime-free; • All targeted participants demonstrate increased employability skills; • Ten of Ten of (100%) participants obtained internships at FTC and other nonprofit partners, and the other five were employed part-tie.			

Conclusion:

The Youth Empowerment Center has demonstrated exceptional effectiveness in achieving its core objectives. The program achieved a 100 percent success rate in academic outcomes, including improved grade point averages, high school graduations, and course promotions. Additionally, YEC participants remained out of the juvenile justice system, a significant indicator of positive youth development and community safety.

The program successfully fostered asset-building skills that enhanced participants' employability and career readiness beyond high school. However, internship and employment placement outcomes showed a 66.67 percent achievement rate, as documented in placement records. This metric reflects only those participants who secured internships or employment through FTC; youth who obtained part-time employment outside the organization were not included in this calculation. A more comprehensive assessment that accounts for all employment secured by participants—both through the program and independently—would provide a fuller picture of the program's impact on workforce development.

Despite the lower employment placement rate, the YEC's success in academic achievement, youth development, and crime prevention demonstrates its significant value to participating youth and the broader Palm Beach County community. The program continues to serve as a vital resource for vulnerable adolescents facing complex barriers to educational and economic success.

Recommendations:

For the 2025–2026 fiscal year, the agency will measure program success by tracking eligible participants who secure part-time employment outside the organization. Additionally, For The Children Inc. will continue its collaborative efforts with the City of Lake Worth Beach to complete renovations of the YEC site. Simultaneously, FTC will pursue capital fundraising initiatives to support the development of Phase 2 of the building project at the Historic Osborne School location.

Embracing the belief that "it takes a village to raise a child," FTC recognizes that strong families and supportive communities are essential to children's success. The organization offers monthly parent and child interactive activities that foster positive relationships and community engagement. These programs include health and wellness initiatives, mentoring support, participation in local and cultural events, and celebrations of youth and staff birthdays and achievements.

Scope of Work:

Demographics:

Youth Empowerment Center (YEC) participants face multiple complex challenges that significantly impact their academic success and future prospects. Economic hardship, food insecurity, and mental health concerns are prevalent among the population served. All participants meet Federal Guidelines criteria for the school free and reduced-price lunch program, indicating their families' low-income status.

Many YEC participants are classified as English Language Learners, a factor that compounds their educational challenges. Coming from immigrant families and representing first- or second-generation Americans, these youth often lack adequate language proficiency and struggle to acculturate to their environment. These linguistic barriers directly contribute to lower academic performance, evidenced by lower grades, increased course failure, and credit deficiency.

Educational obstacles are further intensified by heightened graduation assessment requirements. Recent changes to Florida's assessment policies have increased the rigor of the Scholastic Aptitude Test (SAT) concordant scores required for graduation, and students may no longer substitute a passing score from the Postsecondary Education Readiness Test (PERT) in place of the Algebra End-of-Course (EOC) exam. These policy shifts create additional barriers for struggling learners.

The YEC receives funding from the Palm Beach County Youth Services Department to address these multifaceted challenges and support participant success. The program attracts significant interest among older youth, particularly those seeking summer socialization opportunities and access to educational field trips that their families cannot otherwise afford.


Program Demographics

















Conclusions:
