SUMMARY:

Amendment 6 to Emergency Repair Agreement and Amendment 1 to Work Order #7 with B&B Underground Construction, Inc. to install new emergency water interconnect with Town of Lantana for a cost not to exceed \$73,188.59.

BACKGROUND AND JUSTIFICATION:

The City of Lake Worth Beach water distribution system currently has a valved connection to the Town of Lantana water distribution system to be opened in the case of an emergency. In order to quantify water transferred through this interconnect, the City is installing a new interconnect with a meter assembly. Upon excavating the existing connection, pipe and valve configuration was found to be different than record drawings indicated. This Amendment includes changes necessary to complete the work on newly acknowledged existing assembly configuration. The Amendment to the Emergency Repair Agreement is included in this item to add the necessary additional items to the Agreement that are included in the Amendment to Work Order 7 and were not previously part of the Agreement.
