FIRST AMENDMENT TO WORK ORDER NO.13

THIS FIRST AMENDMENT TO WORK ORDER NO. 13 ("Amendment") is made as of______, by and between the City of Lake Worth Beach, a Florida municipal corporation located at 7 North Dixie Highway, Lake Worth Beach, Florida 33460 ("City") Hooper Corporation, a corporation authorized to do business in Florida. ("Contractor").

1.0 Project Description:

On <u>10/8/2024</u>, the City issued Work Order No.13 to the Contractor to provide services and work related to the <u>System Hardening and Reliability Improvements Project</u> generally described as the <u>1st Ave S Hardening Circuits 4R0602</u> ("Project").

2.0 <u>Scope:</u>

Under this Amendment the City and Contractor agree to reduce scope of all the work under Work Order No,13. The Contractor's proposed deductive changes are attached hereto and incorporated herein as **Exhibit "1"**.

3.0 Schedule:

The deductive changes to be provided under this Amendment shall be effective immediately.

4.0 Compensation:

This Amendment is issued for a deductive amount of <u>- \$90,324.15</u> from Work Order No. 13. Contractor shall not provide any work or services under Work Order No. 13 (as amended herein) that exceeds this new contractual amount.

The Contractor and the City agree that this Amendment to Work Order No. 13 represents the complete agreement of the parties with respect to the deductive scope and amount as of the date of this Amendment. By approving this Amendment, the Contractor releases any and all claims that it may have against the City under Work Order No. 13 including, but not limited to claims for equitable adjustments, which occurred or accrued prior to the effective date of this Amendment except those claims made in writing to the City prior to the effective date of this Amendment.

5.0 Compliance with section 787.06, Florida Statutes.

By signing this Amendment before a notary public and taking an oath under the penalty of perjury, the CONTRACTOR attests and warrants that the CONTRACTOR does not use coercion for labor or services as defined in section 787.06, Florida Statutes, as amended from time to time.

6.0 <u>Authorization:</u>

This Amendment is issued pursuant to the Contract for <u>System Hardening and Reliability Improvements</u> between the City of Lake Worth Beach and the Contractor, dated <u>09/28/2023</u>, ("Contract" hereafter). If there are any conflicts between the terms and conditions of this Amendment, Work Order No.13, and the Contract, the terms and conditions of the Contract shall prevail; however, the specific scope of services set forth in this Amendment and Work Order No.13 shall take precedence over any other more general description of services.
