Work Order #13 to The Paving Lady authorizes paving and concrete repair work to be completed at the following location:

1. S Lakeside Dr (1st Ave S to 5th Ave S)
2. 2nd Ave S (Golfview to S Palmway)
3. 3rd Ave S (S Palmway to S Lakeside)
4. 5th Ave S (S Lakeside to S Lakeside)
5. S Palmway (1st Ave to Lake Ave)
6. N Lakeside (Lucerne to 2nd Ave N)
7. N Palmway (Lucerne to 2nd Ave N)
8. 3 Alleyways (2 Lake Ave to 1st Ave & 1 Lucerne to 2nd Ave)

BACKGROUND AND JUSTIFICATION:

The City has identified the following list of locations where the infrastructure is in poor condition requiring rehabilitation.

location:

1. S Lakeside Dr (1st Ave S to 5th Ave S)
2. 2nd Ave S (Golfview to S Palmway)
3. 3rd Ave S (S Palmway to S Lakeside)
4. 5th Ave S (S Lakeside to S Lakeside)
5. S Palmway (1st Ave to Lake Ave)
6. N Lakeside (Lucerne to 2nd Ave N)
7. N Palmway (Lucerne to 2nd Ave N)
8. 3 Alleyways (2 Lake Ave to 1st Ave & 1 Lucerne to 2nd Ave)

The City currently has a contract 24-101 with The Paving Lady on an as needed basis. The scope of the work is inclusive of removing and replacing the existing sidewalk and curbing, milling and paving the roadway, striping as well as any ADA improvements. The Work Order for The Paving Lady is not to exceed \$1,119,450.31 and will be paid with funding from Annual Roadway.
