ORDINANCE NO. 2025-01 OF THE CITY COMMISSION OF THE CITY OF LAKE WORTH BEACH, FLORIDA, AMENDING THE CODE OF ORDINANCES, CHAPTER 14. "BUSINESS TAX RECEIPTS AND BUSINESS REGULATIONS". ARTICLE I, "LOCAL BUSINESS TAX RECEIPT", SECTION 14-24, "BUSINESS TAX SCHEDULE" TO PROVIDE AN INCREASE IN THE LOCAL BUSINESS TAX RECEIPT RATES BY FIVE PERCENT (5%) EFFECTIVE JULY 1, 2025, IN ACCORDANCE WITH SECTION 205.0535(4), FLORIDA STATUTES; PROVIDING FOR SEVERABILITY, CONFLICTS, CODIFICATION, AND AN EFFECTIVE DATE

WHEREAS, in accordance with Florida Statutes, section 205,0535, the City established an equity study commission and, on June 6, 1995, adopted Ordinance No. 95-10, which reclassified its businesses, professions, and occupations and revised the City's business tax rate structure; and

WHEREAS, section 205.0535(4), Florida Statutes, allows municipalities to increase the rate of local business taxes up to five percent (5%) every other year by ordinance enacted by a vote of a majority plus one vote of the governing body; and

WHEREAS, the City Commission has, from time to time, found that it was in the City's best interest to increase the business tax receipt rates for all businesses, occupations and professions by 5%, most recently in 2019; and

WHEREAS, the City Commission now finds that it is in the City's best interest to increase the business tax receipt rates for all businesses, occupations and professions by 5% effective July 1, 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAKE WORTH BEACH, FLORIDA that:

Section 2. Chapter 14 "Business Tax Receipts and Business Regulations" Article I, "Local Business Tax Receipts", Section 14-24, "Business tax schedule" is hereby amended to reflect a 5% increase for all businesses, occupations and professions, effective July 1, 2025, to read as follows:

<u>Section 3.</u> Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

<u>Section 4.</u> Repeal of Laws in Conflict. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

<u>Section 6.</u> Codification. The sections of the ordinance may be made a part of the City Code of Laws and ordinances and may be re-numbered or re-lettered to accomplish such, and the word "ordinance" may be changed to "section", "division", or any other appropriate word.

Section 7. Effective Date. This ordinance shall take effect ten (10) days after adoption.
