# AMENDMENT No. 1 TO TASK ORDER No. 3 CONTINUING PROFESSIONAL SERVICES AGREEMENT (Architecture)

## 1.0 **Project Description**:

The City desires the CONSULTANT to provide those services as identified herein and generally described as: **Renovation of the Youth Empowerment Center Building** (the "Project").

## 2.0 Scope

## 4.0 <u>Compensation</u>

This Amendment is issued for a lump sum, not to exceed amount of <u>30,000.00.</u>. The attached proposal identifies all costs and expenses included in the lump sum, not to exceed amount. CONSULTANT shall be solely responsible for any and all amounts which exceed those stated in "Exhibit 1" unless approved in writing by the City.

If there are any conflicts between the terms and conditions of this amendment, this Task Order and the Agreement, the terms and conditions of the Agreement shall prevail.

Dear Mr. Tawadros.

Song + Associates, Inc. respectfully requests approval of this Additional Service Proposal for Roofing Consultant Services related to the following changes in the scope of work.

## I. PROJECT UNDERSTANDING:

Additional Scope of Work and Roofing Consultant Services: The original contract scope and fees dated October 16, 2024 described a full roof replacement of the existing 1,502 sf asphalt shingles roof for the Youth Empowerment Center building only with a similar in-kind roofing system. With the intent to have a better usage of the federal grant to be allocated to the project, the Owner has requested the roofing system to be upgraded to a concrete barrel tile roof system similar to the adjacent Osborne Community Center Building. The Owner has also requested to include replacing the existing 10,034 sf barrel tile roof on the Osborne Community Center.

For this reason, the Owner is requesting the inclusion of a third party Roofing Consultant to develop the appropriate roofing specifications and detailed drawings as well as to assist during the bidding and construction administration phases with the review and inspection of the roof scope of the project for both buildings.

#### II. ADJUSTED SCOPE OF SERVICES AND ADDITIONAL SERVICES:

#### A. Changes to Proposed Building Renovation Scope, Size and Form

The above described changes require additional Architectural Design and Construction Administration Services. The construction documents will be updated in accordance with the above described scope to a 100% level of development. The proposed additional services fees reflect the additional work required for the increased scope. The additional proposed fees will be apportioned as required to the remaining phases of Construction Documents, Permitting/Bidding, and Construction Administration.
