Amendment No. 1 to Task Order No. 3 for Song & Associates, Inc.

SUMMARY:

This task order amendment authorizes Song & Associates, Inc. to add the services of roofing subconsultants to the existing task order No. 3 for the Youth Empowerment Center Renovation Project at a cost not to exceed \$30,000.00

BACKGROUND AND JUSTIFICATION:

The Youth Empowerment Center Renovation Project is an approved Community Development Block Grant (CDBG) project administered by the Palm Beach County Department of Housing and Economic Development. The City recently submitted a request to amend the grant agreement to include the replacement of the Osborne Community Center roof, located on the same parcel, due to the roof reaching the end of its useful life. This request was approved.

This task order amendment authorizes Song & Associates, Inc., the architect of record for the project, to engage roofing sub-consultants under task order No. 3. The amendment includes design and construction services for the Osborne Community Center roof replacement and upgrades the roofing material for the Youth Empowerment Center from shingles to roofing tiles.

The cost of this amendment is not to exceed \$30,000.00, bringing the total task order amount to \$67,330.00.
