**TITLE:**

Ordinance No. 2025-01 – Second Reading - increase Business Tax Receipt rates by five percent (5%)

**SUMMARY:**

The ordinance amends the City Codes to provide for a five percent (5%), across the board Business Tax Receipt rate increase effective for Fiscal Year 2026 beginning with the annual renewals for that year that are sent out in the summer.

**BACKGROUND AND JUSTIFICATION:**

The City of Lake Worth Beach's last Business Tax Receipt increase was for Fiscal Year 2020. Under Florida Statue 205.0535, the City can raise the rates as much as five percent (5%) every other year as long as the City has adopted an Equitable Rate Study. The City did adopt such a study in 1995 and can effectively raise the established Business Tax Receipt rates by five percent (5%). Based on collections during Fiscal Years 2023 and 2024, it is projected that the change will increase revenues by at least \$30,000. In addition, the increase maintains our competitiveness with regard to adjacent municipalities, as the City's rates remain lower in most categories.

The ordinance passed unanimously at the May 20, 2025 city commission meeting.
