Agreement with Loc Pump & Equipment Company of Florida, Inc. d/b/a Tiffskid to purchase Two Triplex Sodium Hypochlorite Skid Pump Systems and Two Triplex Acid Skid Pump Systems

SUMMARY:

Goods and Service Agreement with Loc Pump & Equipment Company of Florida, Inc. d/b/a Tiffskid to purchase Two Triplex Sodium Hypochlorite Skid Pump Systems and Two Triplex Acid Skid Pump Systems at a cost not to exceed \$163,909.58.

BACKGROUND AND JUSTIFICATION:

As part of the replacement of the City's existing chemical dosing skids, the City issued Invitation for Bid #25-113 for the purchase of Two Triplex Sodium Hypochlorite Skid and Two Triplex Acid Skid Pump Systems ("IFB") for the City's Water Utility.

A total of three (3) bids were received. After evaluation, the agreement was recommended to Loc Pump & Equipment Company of Florida, Inc., d/b/a Tiffskid as the lowest bidder. These chemical dosing systems are intended for integration into the City's Water Utility infrastructure, supporting ongoing water treatment operations. Each skid is designed to ensure safe, efficient, and reliable chemical injection for critical water treatment applications.
