

RESOLUTION NO 55-2025 – A RESOLUTION OF THE CITY OF LAKE WORTH BEACH, FLORIDA, ADOPTING THE FINAL NON-AD VALOREM ANNUAL ASSESSMENT ROLL FOR FISCAL YEAR 2025 - 2026 TO CONTINUE PROVIDING A UNIFORM METHOD FOR COLLECTING A NON-AD VALOREM ASSESSMENT FOR REFUSE SERVICES, FACILITIES, AND PROGRAMS; AND PROVIDING FOR CONFLICTS AND AN EFFECTIVE DATE.

WHEREAS, the City of Lake Worth Beach previously adopted Ordinance No. 2009-22 (as amended from time to time, and as codified in Chapter 2, Article XVIII of the City Code of Ordinances, the "Assessment Ordinance"), City Resolution No. 41-2009 (as amended and supplemented from time to time, and as particularly supplemented by Resolution No. 46-2009, the "Initial Assessment Resolution") stating the intent of the City to use the Uniform Method of Collecting a Non-Ad Valorem Assessment for refuse services, facilities, and programs ("Refuse Services") for all parcels within the incorporated boundaries of the City; and

WHEREAS, the City Commission has determined that the current rate charged for the cost of providing Refuse Services has not increased since adoption of the Fiscal Year 2024-2025 Annual Assessment Resolution (Resolution No. 22-2024), which set the rate of Solid Waste Services Assessments at \$271.55 per ERU per year consistent with the Assessment Ordinance and Initial Assessment Resolution; and,

WHEREAS, the City Commission has determined the final non-ad valorem assessment roll for fiscal year 2025- 2026 on all parcels within the incorporated municipal boundaries of the City shall remain at \$271.55 per ERU and per year thereafter until changed; and,

WHEREAS, the City Commission finds the adoption of this Resolution serves a valid public purpose.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAKE WORTH BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified as being true and Correct and inc.

Section 2. The Final Non-Ad Valorem Assessment rate per computed parcels for the City of Lake Worth Beach for the Fiscal Year 2025 - 2026 is hereby set as \$271.55 per ERU, which is the same as charged in Fiscal Year 2024 – 2025.

Section 3. The Refuse Services Assessment Roll, which is on file with the City Clerk and incorporated herein by reference, is hereby approved. The Refuse Services Assessment Roll shall be certified to the Tax Collector by September 15, 2025, pursuant to Section 197.3632(5), Florida Statutes.

Section 4. All resolutions or parts of resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. This Resolution shall take effect immediately upon adoption.
