## **SUMMARY:**

Task Order 5 with JLA Geosciences, Inc. for Surficial Aquifer Production Well Rehabilitation Design, Bidding and Construction Phase Services for a cost not to exceed \$66,952.

#### **BACKGROUND AND JUSTIFICATION:**

The City of Lake Worth Beach (CITY) entered into a Professional Services Agreement with JLA Geosciences, Inc., (CONSULTANT) on March 28, 2023, under RFQ No. 23-300. This agreement is for CONSULTANT to provide CITY with professional hydrogeological services. The purpose of this Scope of Services is to provide the CITY with professional engineering and hydrogeological services to conduct Surficial Aquifer Production Well Rehabilitation Design, Bidding and Construction Phase Services. The proposed scope of work includes rehabilitation of wells 3, 6, 7, and 14. This scope of work was developed based on recommendations from the 2025 wellfield testing. JLA's scope of work will include coordination of rehabilitation work; development of rehabilitation plans; field supervision, water quality and well performance testing during rehabilitation work; and documentation of rehabilitation results.
