SUMMARY:

Work Order #1 to The Paving Lady authorizes paving and concrete repair work to be completed at the following locations:

- 1. North B Street Lucerne Avenue to 6th Avenue North
- 2. North D Street 10th Avenue North to 13th Avenue North
- 3. 15th Avenue North North M Street to Federal Hwy
- 4. 15th Avenue North Federal Hwy to North N Steet

BACKGROUND AND JUSTIFICATION:

The City has identified the following list of locations where the infrastructure is in poor condition requiring rehabilitation.

- 1. North B Street Lucerne Avenue to 6th Avenue North
- 2. North D Street 10th Avenue North to 13th Avenue North
- 3. 15th Avenue North North M Street to Federal Hwy
- 4. 15th Avenue North Federal Hwy to North N Steet

The City currently has a contract with The Paving Lady on an as needed basis. The scope of the work is inclusive of removing and replacing the existing sidewalk and curbing, milling and paving the roadway, apply new roadway striping as well as any ADA improvements.

The Work Order is not to exceed \$624,341.03 and will be paid for with funding from Roadway Improvement Fund.
