CentralSquare Technologies, LLC Agreement for NaviLine Cloud Hosted Environment

SUMMARY:

Agreement with CentralSquare Technologies, LLC and the City of Lake Worth Beach for NaviLine Cloud Hosted Environment

BACKGROUND AND JUSTIFICATION:

The Information Technology Department is currently hosting the NaviLine Enterprise Resource Planning (ERP) System on-premise. This system is used citywide and is critical for the operation of the City. The NaviLine IBM server was purchased March 2016 and IBM recently announced end of hardware support effective 2024. IT is seeking to migrate the NaviLine ERP system from the current IBM on-premise server to CentralSquare NaviLine cloud hosted environment. Main benefits are business continuity, resiliency, accessibility, redundancy, disaster recover, minimize and mitigates risks, system management and software upgrades conducted by vendor, 24/7 system monitoring and support.

FY 2023 current cost to host on-premise is \$184,010. The cost to replace the IBM server is estimated at \$52,700 for a total expense of \$236,657. FY 2024 estimated expense is \$190,025, excludes IT staff resources dedicated to maintain and support the server, hardware and software.

FY 2023 cost for cloud hosted environment is \$207,798, includes one-time cost expenses for the migration. NaviLine software maintenance and support of \$132,169 was paid October 2022, therefore, the net cost for FY 2023 is \$75,629. Thereafter, the cost for the subsequent fiscal years will be for software maintenance and support, and cloud hosting services; FY 2024 expense \$199,000.
