WHY DO YOU DESIRE TO SERVE ON THIS BOARD (FIRST PREFERENCE)

The CRA is a key part of our city's future development, as much as it has been in the past. I'd like to step into the middle of it and see that the choices made are done, at the least, with an eye to balance between aggressive development and the latest quirks of public mood. The NSP2 grant succeeded in bringing homes to many families, but today's affordable housing needs would have been better served with a land trust model. Of course, 15 years looks long-term at the beginning of the mortgage.

I'd bring to the board a voice for parts of the CRA district outside the Lake/Lucerne area, with my experience in the south end of the city. As a founder of the Whispering Palms NA, I have seen the efforts of the CRA occasionally touch our purview, and I'd work to increase such opportunities. I'm a fan of the Strong Towns view of how to do development, understanding that it is not growth that is the problem, but growth that does not take into consideration the elements of human life that make living in a place worthwhile. As a business owner of an RV park, the second oldest business in Lake Worth, I am invested in the long term health of our city, and its existence as a desirable destination. Don't appoint me if I annoy you, unless you want to be annoyed for a long while.

I've been active for over 15 years when our vociferous community comes together in charettes, NA meetings, and city meetings. I have a record of forming, building, and persisting with community organizations.

By training and inclination I am a social worker (MSW, UNC-CH 2005), and have been Treasurer for a business that has grown greatly, suffered setbacks, adapted, and is now drawing on both city and county traffic and resources. As a stop on the thin metro area that Lake Worth Beach is, getting a seat at the table for community voices will make an important difference.

I've followed local government long enough to say I have a beginning grasp of the budget cycle.

My work at the south end of our city gives me an ear for voices that are sometimes not present in government planning and for business interests.
