The subcommittee would be comprised of three council members, as well as the Village Manager and the Police Chief.

Council members engaged in a discussion that included several concerns regarding the formation of a subcommittee. Topics raised included the Township's potential involvement, the importance of respecting residents' rights, possible legal implications, and whether a subcommittee is the

appropriate approach—especially given that council meetings are televised while subcommittee meetings are not. Additional concerns were expressed about public safety and the possibility of consulting with the Village's attorney.

Dan Nelson, representing the Lake Orion Lake Association (LOLA), shared that he has had previous conversations with the Township and indicated there is a willingness on their part to collaborate with the Village on this matter.

Rosemary Ford expressed concerns regarding public access and questioned whether state-managed public boat launches should be included in the scope of the subcommittee's discussions.

MOTION made by Council member Dandalides, Seconded by Council member Lamb to AMEND the previous motion to create a council subcommittee to review the top priority issues presented by LOLA, other residents, and consistent with the Village Master Plan, and come back to council with recommended solutions to address those issues. The subcommittee would be comprised of Council Member Dandalides, Council Member Lamb, and Council Member Comparoni, as well as the Village Manager and the Police Chief and to include a representative from the Township. Committee to report back to Council no later than the July 28 2025 council meeting.

Council Member Lamb suggested formatting changes to the Draft Strategic Action Plan, including using black text, removing images, and adding the legend to each page. He supports the document but noted formatting issues. Council Member Moshier agreed on using black and white and raised concerns about the survey demographics. President Rutt suggested increasing engagement through the website, and Council Member Lamb recommended including future surveys in newsletters. President Pro Tem Ford acknowledged the small survey sample, and Council Member Dandalides noted the survey closed on April 4.

Dan Nelson spoke about various access points on the lake, raising concerns about keyholing and overall safety. He also expressed frustration with forming subcommittees that result in no action.

Jim Barry addressed issues of overcrowding on the lake and potential legal concerns, emphasizing that local authorities have the ability to manage these matters. He stressed that safety remains the top priority for the lake.

#### 12. Council Comments

Council Member Dandalides had no comments.

President Pro Tem Ford acknowledged the weekend protests, expressed appreciation that Parks and Recreation activities continued, and thanked LOLA for their donation to the Police Department. He noted the importance of Township involvement in addressing lake-related issues.

Council Member Moshier thanked residents for attending, congratulated Rosemary Ford on her term extension, and shared a brief update on the wood ducks near her home.

Council Member Comparoni, Jr. noted the progress made on lake issues and expressed hope that the subcommittee will develop effective solutions.

Council Member Cyrowski shared a complaint from local businesses regarding the weekend protest and asked about the type of information available in advance of such events.

Council Member Lamb shared data on lakefront property growth and taxable values. He also commented on the DDA budget format, requesting consistency with other departments, and voiced concerns about the lake.

President Rutt reviewed the public comment policy, reminding residents that Council cannot respond during public comment to maintain order. She also addressed the weekend protest, noting that while such events can be disruptive, the right to protest must be respected.

#### 13. Village Manager Comments

Chief Amundson informed Council that the Village Manager's Report would be emailed to them following the meeting. He briefly addressed the weekend protests and noted that, moving forward, the DDA Executive Director would be included in communications about such events to keep business owners informed. He also provided brief comments on the marina ordinance and keyholing issues on the lake
