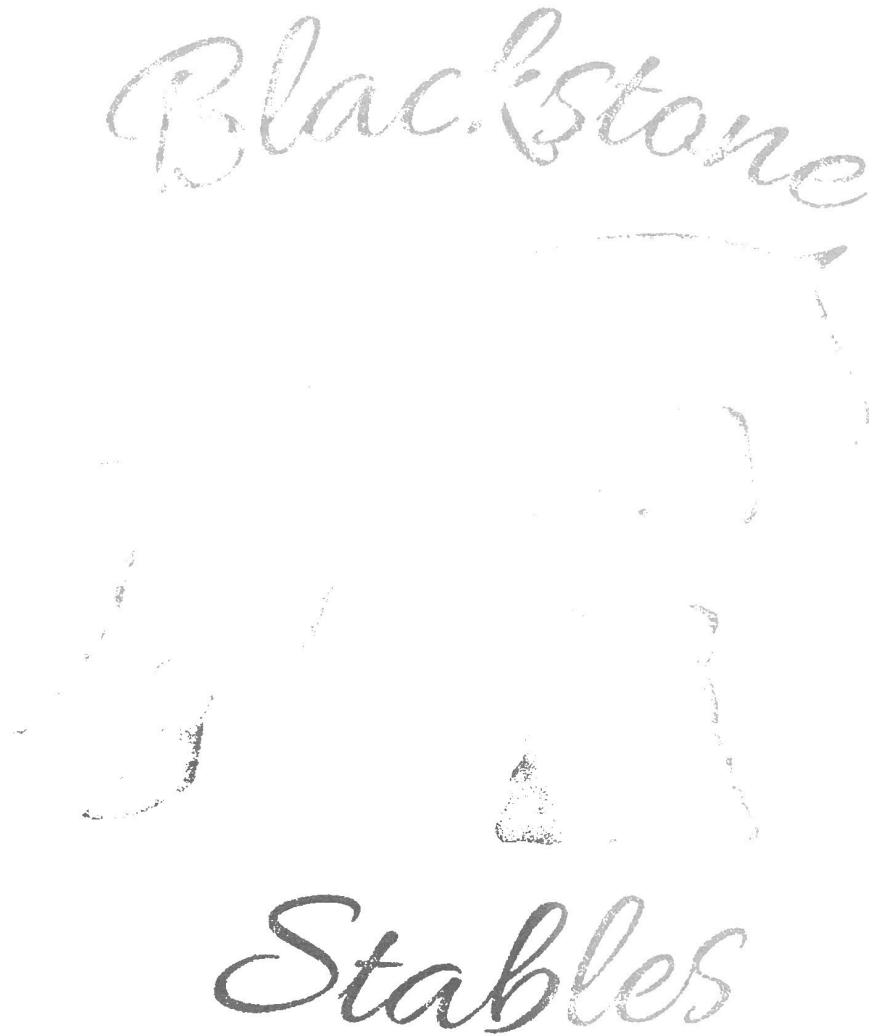

***Parking must be provided for 2 trucks & trailers close to the event.**

- Hills, Mileage, and route must be agreed upon prior to accepting. If deemed unsafe the route may be altered.

- We CAN NOT cross major roads, unless it is a special event such as a parade where the road is blocked off with proper road closures/ traffic co



- Horses move much slower than cars, therefore we will NOT TRAVEL on expressways or interstates.
- Blackstone Stables Horse Drawn Carriage Co. will work in most weather. If deemed unsafe, we reserve the right to reschedule the event.

- All deposits are Non-Refundable
- We will charge an additional fee for an event that runs over the scheduled time.
- Parking for the truck and trailer must be located on a low- or no-traffic side street or a parking lot. We need approximately 15 parking spaces to park and set up. We must be 1/4 miles or less from the event.
- We will not be responsible for any negligence of the passengers on the carriage. All passengers must remain seated while the carriage is moving. Children under 12 years old must be accompanied by a parent or guardian.
