RESOLVED: To approve the Special Event Permit Application submitted by Lloyd Coe on behalf of the American Legion and Sons of American Legion for the Downtown Lake Orion Cornhole League to be held every Thursday night beginning June 5, 2026 until September 10, 2026 between 6:45PM and 9:30PM at various Village properties, as outlined in the application.

Public sidewalks to be utilized are as follows:

- Sidewalk behind Sick Pizza
- Sidewalk in front of American Legion
- Sidewalk in front of Irish Tavern
- Sidewalk in front of Builders Custom Flooring
- Sidewalk behind Johnny Black's Lakehouse
- Sidewalk adjacent to Ed's Broadway Gift

FURTHER RESOLVED: To approve the License Agreement between the Village of Lake Orion and the American Legion and Sons of American Legion and to authorize the Village President and Village Clerk to execute the Agreement on behalf of the Village.

FURTHER RESOLVED: This approval is conditioned on the following:

Administrative Requirement:

1. The applicant is responsible for cleaning up any trash generated during the event.

DPW Requirement:

1. Village properties will be properly maintained before and after the event.

Police Requirements:

1. A clear and unobstructed pedestrian path must be maintained at all times within the public right-of-way. Cornhole boards, participants, and spectators shall not impede sidewalk access, and sufficient space must remain for pedestrian passage.
2. The special event permit does not authorize the possession or consumption of alcohol. Any alcohol present must comply with applicable laws and any established social district regulations.
3. Alcohol must originate from an approved social district vendor and be contained within a designated, approved container.
4. The presence of alcohol in cans, bottles, or non-approved containers is prohibited and will be subject to enforcement action.
5. Activities are strictly limited to the locations identified in this permit. Expansion beyond the approved areas is not permitted without prior authorization and may result in enforcement action and/or revocation of the permit.

Fire Department Requirement:

1. There shall be no parking in the Fire Station parking lot or along Anderson Street.
