**RESOLUTION TO APPLY FOR STATE DISASTER CONTINGENCY FUND GRANTS
UNDER SECTION 19 OF THE EMERGENCY MANAGEMENT ACT, 1976 PA 390, AS
AMENDED**

At a meeting of the Village Council of the Village of Lake Orion, County of Oakland, State of Michigan, held on July 13th, 2026, at 21 E. Church Street, Lake Orion, MI 48362 at 6:00 p.m., there were:

WHEREAS, the Village of Lake Orion is a Michigan municipal corporation located in Oakland County, Michigan with an official Emergency Operation Plan in compliance with Section 19 of the Emergency Management Act, 1976 PA 390, MCL 30.419, as amended; and

WHEREAS, the Village of Lake Orion sustained severe losses of major proportion brought on by the May 10, 2026, GLWA Water Main Break which caused a widespread disruption of the public water supply, necessitated emergency response operations, emergency protective measures, the procurement of emergency water supplies, and other actions necessary to protect the public health, safety, and welfare

WHEREAS, the Village Council certifies that the Village of Lake Orion's Emergency Operations Plan was implemented at the onset of the disaster on May 6, 2026 and all applicable disaster relief forces identified therein were exhausted; and

WHEREAS, as a direct result of the disaster, public damage and expenditures were extraordinary and places an unreasonably great financial burden on the Village of Lake Orion totaling \$10,555.06, consisting of \$8,299.76 in eligible expenditures incurred by the Village of Lake Orion.

THEREFORE, BE IT RESOLVED, that the Village Council requests the Governor authorize a grant to the Village of Lake Orion from the State Disaster Contingency Fund pursuant to Section 19 of the Emergency Management Act, 1976 PA 390, MCL 30.419, as amended.

BE IT FURTHER RESOLVED, that Chief of Police / Emergency Manager, Mark Amundson, is authorized to execute for and on behalf of the Village of Lake Orion the application for financial assistance and to provide to the State with any information required for that purpose.
