RESOLVED: To approve the Event Permit Application submitted by Emily Dziegielewski on behalf of Lake Orion Downtown Development Authority, dated January 7, 2025, for the Ice Fest to be held on Saturday, February 1, 2025, to be held from 10:00 AM – 6:00 PM at sidewalks up against the buildings on Broadway and Flint Street as outlined in the application, which is attached.

FURTHER RESOLVED: To approve the License Agreement between the Village of Lake Orion and Lake Orion Downtown Development Authority, Emily Dziegielewski/Janet Bloom - and to authorize the Village President and Village Clerk to execute the Agreement on behalf of the Village.

FURTHER RESOLVED: To approve the sign permit for the 2025 Ice Fest, as submitted.

FURTHER RESOLVED: This approval is conditioned on the following:

Administrative Requirements

1. The cellular telephone numbers of event staff and on-scene managers must be provided to the Police Department within twenty-four (24) hours of the event.
2. Written permission from the property owner is required for posting signs.
3. DDA will reimburse the Village for actual DPW cost associated with setup.

DPW Requirements

1. The use of Village orange cones will be based on availability.
2. DPW will not supply extension cords or cord covers.
3. A work order should be created on Silversmith for the 48 cinder blocks and 8 barricades (4 at each live carving station) to reserve parking spaces and maintain a safe distance for spectators.

4. As always, Village properties will be properly maintained before the event begins and after the event ends.

Fire Department Requirements: (Waiting for a response) approval is contingent on meeting all the requirements of the Fire Department.
