

RESOLUTION

AUTHORIZING EXECUTION OF DOCUMENTS AS REQUIRED TO DESIGNATE AUTHORIZED SIGNATORIES WITH PNC BANK

WHEREAS, the Lake Orion Downtown Development Authority ("LODDA") is a duly formed and authorized public corporate body possessing all powers and rights granted by the DOWNTOWN DEVELOPMENT AUTHORITY ACT 197 of 1975, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and

WHEREAS, the LODDA presently maintains a corporate depository account with PNC BANK, conducting business through its branch in Lake Orion, Michigan; and

WHEREAS, Matthew A Gibb has recently been appointed by the LODDA, as approved by the Village of Lake Orion, to act and hold the position of Executive Director of the LODDA, replacing Molly Lalone, necessitating a change in the signature card for the account at PNC BANK; and

WHEREAS, such signatories have, in the past, been the Executive Director and the LODDA Board Chair, it therefore being the intent of the LODDA to amend and update the signature card.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Lake Orion Downtown Development Authority:

<u>SECTION ONE:</u> The recitals set forth above are incorporated herein and made a part hereof.

<u>SECTION TWO:</u> The Executive Director, Matthew A Gibb, and Board Chairwoman Debbie Burgess, are authorized signatories on behalf of the LODDA, and are hereby authorized to execute all necessary forms, resolutions or cards provided by PNC BANK, designating or affirming the Bank as a depository, and designating these individuals as signatories for such for purposes as set forth therein, the LODDA adopting all such PNC BANK authorizing materials as though fully set forth herein.

<u>SECTION THREE:</u> This Resolution shall take effect immediately upon its passage and approval as provided by law.

RESOLVED FURTHER, that any checks, drafts, orders or any other withdrawal order including any withdrawal and/or transfer of funds requested to be made by electronic or similar means and any and all other directions and instructions of any character with respect to funds of this corporation with the Bank (each of the above is individually and collectively referred to as the "Item") may be signed or initiated without signature by any one of the following or by any person purporting to be authorized by and one of the following:
