A RESOLUTION DETERMINING TO PROCEED WITH THE 2025 SIDEWALK IMPROVEMENT PROGRAM DISTRICT #1 PROJECT TO BE DEFRAYED BY SPECIAL ASSESSMENT; CORRECTING AND CONFIRMING THE SPECIAL ASSESSMENT ROLL THEREFOR; AND DIRECTING THE PLACEMENT OF THE SPECIAL ASSESSMENTS ON THE VILLAGE OF LAKE ORION TAX ROLL FOR COLLECTION

WHEREAS, Village of Lake Orion Administration has inspected and prepared an inventory of necessary sidewalk repairs and improvements within the Village; and

WHEREAS, the list of necessary repairs and improvements has been submitted to the Village Council, together with estimates of costs, pursuant to Chapter 12 of the Village of Lake Orion Charter; and

WHEREAS, the Village Council of the Village of Lake Orion desires to cause the completion of sidewalk repairs and improvements within the Village of Lake Orion Sidewalk Improvement Program (SWIP) District #1 (map attached hereto) to replace deficient sidewalk slabs throughout SWIP District #1 at a total cost of \$17,607.00; and

WHEREAS, the Village Council held a public hearing on the necessity of the proposed sidewalk improvements, after required notice, on _____ and directed the Village Assessor to prepare a proposed special assessment roll to defray a portion of the costs of the project against abutting benefitting properties; and

WHEREAS, the Village Council held a public on the proposed special assessment roll, after required notice, on April 28, 2025, and directed the Village Assessor to make corrections to the proposed roll for further consideration by the Council; and

WHEREAS, the Village Council has received the proposed corrected special assessment roll;

NOW, THEREFORE, BE IT RESOLVED that the Lake Orion Village Council does hereby determine to proceed with the 2025 Sidewalk Improvement Program (SWIP) District #1 public improvements; and

BE IT FURTHER RESOLVED that the Village Council does hereby make the following corrections to the 2025 Special Assessment Roll for the Village of Lake Orion 2025 Sidewalk Improvement District #1 project:

- 1. Remove the property located at 59 N. Washington (Parcel No. OL-09-02-7-479-005) from the special assessment roll totaling \$224.00; and
- 2. Remove the property located at 505 E. Flint (Parcel No. OL-09-01-302-023) from the special assessment roll totaling \$392.00; and

BE IT FURTHER RESOLVED that the Village Council does hereby confirm the 2025 Special Assessment Roll for the Lake Orion Sidewalk Improvement District #1 special assessments (SAD 2025-01) in the total amount of \$15,178.00;

BE IT FURTHER RESOLVED that the Village Council does hereby direct that special assessments shall be spread over up to three (3) years in \$500 increments with any remaining balance to be paid in the third year; and


BE IT FURTHER RESOLVED that the Village Council does hereby direct that special assessments remaining unpaid after the payment due date for the 2025 tax roll shall bear an interest cost of six percent (6.00%) per annum until paid; and

BE IT FURTHER RESOLVED that the Village Council does hereby direct that special assessments may be paid in full at any time, thereby limiting the interest cost to be charged in accordance with Chapter 12 of the Village of Lake Orion Charter; and

BE IT FURTHER RESOLVED that the Village Council does hereby direct that the special assessments be placed upon the Village tax roll for collection pursuant to Section 12.5 of the Village of Lake Orion Charter.

Statement of Intent:

This Special Assessment District and Roll has been established under the authority of the Village of Lake Orion Charter (Chapter 11 Section 2, Chapter 12) to collect \$ 15,794 over a three (3) year period, beginning with the July 1, 2025 tax roll, for the purpose of sidewalk improvement and maintenance activities.

The Special Assessment District includes 45 real property parcels in the Sidewalk Improvement Program District #1. Each parcel's total cost is based on the number of square feet of sidewalk required to be built or rebuilt adjacent to each parcel of land. Each parcel subject to the assessment will be charged no more that \$500 per year starting with the first of the three (3) years until the total cost per parcel has been paid. Property owners will be charged a 6% annual interest fee in the event the assessment goes unpaid.
