A RESOLUTION SUPPORTING THE SUBMISSION OF THE VILLAGE OF LAKE ORION FY 2026 COMMUNITY SERVICE INFRASTRUCTURE (TRANSPORTATION ECONOMIC DEVELOPMENT FUND CATEGORY B) GRANT APPLICATION AND DESIGNATING THE VILLAGE MANAGER AS AUTHORIZED REPRESENTATIVE FOR THE PROJECT.

WHEREAS, the Village of Lake Orion recognizes the need to make improvements to its existing local road system; and

WHEREAS, the Village of Lake Orion authorized Nowak & Fraus Consulting Engineers to prepare a Pavement Asset Management Plan, which recommends the maintenance and improvement of local road condition ratings to eventually meet statewide averages through a series of annual Preventative Maintenance and Pavement Rehabilitation treatment programs; and

WHEREAS, the Village of Lake Orion authorized Nowak & Fraus Consulting Engineers to prepare a FY 2026 Community Service Infrastructure Fund (CSIF) grant application, commonly referred to as TEDF Category B, based on said Pavement Asset Management Plan; and

WHEREAS, the proposed Treatment Program "A" includes pavement rehabilitation, preventative maintenance and drainage improvements to

- Clare Street
- Grove Street
- Lake Street, from the west dead end to Darling Drive (future Portside Drive)
- Axford Street, from Lake Street to W. Flint
- Andrews Street, from Lake Street to W. Flint
- W. Flint Street, from North Shore Drive to M-24
- North Shore Drive from Lake Street to Church Street

with a total estimated construction cost of \$547,000 of which the Village of Lake Orion will request \$250,000 in the FY 2026 Community Service Infrastructure Fund (CSIF) TEDF Category B grant application, with the Village of Lake Orion contributing matching funds of \$250,000 plus the remaining \$47,000.

NOW, THEREFORE, BE IT RESOLVED that the Village of Lake Orion village council formally adopts this Resolution of Support for submitting the FY 2026 Community Service Infrastructure Fund (CSIF) grant application requesting \$250,000 for the said Treatment Program "A"; and

BE IT FURTHER RESOLVED that the Village Manager, a position currently held by Darwin D. P. McClary, is designated as the authorized representative for all activities associated with the project referenced above, including the submittal of said FY 2026 Community

Service Infrastructure Fund (CSIF) grant application.
