It is also expressly understood and agreed to by and between the parties hereto that nothing herein contained shall operate to discharge or release Lessee from the liabilities to promptly perform each of the terms and conditions contained in the original Lease and License, which are attached hereto and made a part hereof.
- 3. This Extension of Lease, in conjunction with the basic Lease (Exhibits "A"), sets forth the entire agreement between the parties. The original Lease as extended and this Extension of Lease shall not be altered or modified hereafter, except by a written memorandum signed by the parties.
- 4. This agreement shall be attached to the basic Lease, Exhibit "A" attached hereto, and shall become a part thereof as if originally included therein.
