- 2. Receipt by the city clerk of a notice of sales tax delinquency and a Sales Tax Hold Notice from the State of Wyoming issued pursuant to W.S. 12-2-306, as amended.
- 3. That the premises, while licensed in the name of the holder, are the scene of repeated or continuing violations of any ordinance or law, and that the initial violation occurred while the premises were licensed in the name of the holder and the holder had knowledge of the first violation or delays correcting a continuing violation.

The potential consequences of a finding that WILD WEST WAREHOUSE D/B/A GRIZZY BAR & Grill violated Lander Municipal Code 2-2-6 include but are not limited to a fine, suspension and/or revocation of the licensee's license

NOTICE IS HEREBY PROVIDED, that a hearing shall be held in the Courtroom of the Lander Municipal Court at 250 Lincoln Street, Lander Wyoming on the 10th day of June, 2025 at 6:00 p.m., during the Regular City of Lander Council Meeting for the purpose of allowing the liquor licensee to offer corrections to the information, and action taken by the liquor licensee to mitigate the violation and for the Governing Body to determine whether the liquor licensee should face restrictions or suspension of the liquor license.

Adverse final decisions made by the City of Lander may be appealed to the District Court in accordance with the Wyoming Rules of Appellate Procedure.
