### **RESOLUTION 1367**

# A RESOLUTION DECLARING CERTAIN POLICE DEPARTMENT TASERS AS SURPLUS PROPERTY AND AUTHORIZING THEIR DISPOSAL VIA PUBLIC AUCTION TO A QUALIFIED BIDDER, PURSUANT TO WYOMING STATUTE § 15-1-112

WHEREAS, the City of Lander Police Department currently owns FIFTEEN x2 Taser devices, which are obsolete or no longer used in departmental operations; and

WHEREAS, these Tasers have an estimated fair market value of \$500 or more each; and

WHEREAS, Wyoming Statute § 15-1-112(a) requires that, before a municipality may sell property valued at \$500 or more, the city must publish an advertisement at least once each week for three consecutive weeks in a newspaper of general circulation in the community, describing the property and the terms of sale—either a public auction or sealed bids—and that the property be sold to the highest responsible bidder unless the governing body rejects all bids; and

WHEREAS, the City of Lander seeks to comply fully with this statutory process, ensuring both transparency and return to the public; and

NOW, THEREFORE, BE IT RESOLVED BY the Governing Body of the City of Lander, Wyoming, that:

- 1. The following items are hereby declared surplus property:
  - Taser Model X2, Serial Numbers: X29008EH5, X29008EHH, X2900ATYH, X2900C2C7, X2900923C, X2900AVAV, X2900AV9X, X2900AVC3, X29006278, X2900AV9D, X2900AVA1, X2900C210, X2900DXE2, X2900AVAD AND X2900F7A8
  - EACH TASER INCLUDES TWO LOADED CARTRIDGES AND BLACKHAWK HOLSTER
- 2. The City Clerk, in coordination with the Chief of Police, is authorized to publish notice of the sale in accordance with W.S. § 15-1-112(a):
  - Timing: At least once per week for three consecutive weeks, in a newspaper of general circulation in Lander.
  - Content: Description of the Tasers, terms of the sale and instructions for interested bidders.
- 3. The Tasers shall be sold to the highest responsible bidder, unless the City Council determines to reject all bids, in accordance with W.S. § 15-1-112(a).
- 4. The City reserves the right to reject any or all bids and to withdraw any item from the auction prior to sale.
- 5. All proceeds from the sale of the surplus Tasers shall be deposited into the appropriate City fund in accordance with City policy and applicable financial procedures.
- 6. This resolution shall be effective immediately upon adoption, and the sale process shall commence following adoption of this Resolution.

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized and directed to execute, and the City Clerk to attest, any necessary documents to dispose of the surplus property.
