pulled truck into the shop. connected to the truck and found no active codes then connected to the abs module and found codes for the brake switch and the rear pump motor. removed the brake switch to check for fluid passing and found none. then tested the circuit from the switch to the module and found it is good. then tested the powers and ground to the hbp all are good. at this time the truck is showing signs the hbp is going out and will need to be replaced. we will also quote the replacement of the brake switch as well.
