### COUNCIL CONSIDERATION OF AGENDA ITEMS:

### **Approval of Ordinance No. 1116**

Pursuant to Chapter 16, Utilities, Section 16-116 and 16-209 (e), the City Council is to be presented with a list of delinquent accounts and the customer's information. Upon adoption by the City Council and subsequent publication in the Leavenworth Times, this Ordinance shall constitute a lien against the real estate for which service is supplied. Staff does not submit this ordinance for assessment until August 25, 2024. Residents are given the opportunity to be removed from the Ordinance by setting up a payment plan with the city before that date

Councilmember Robinson made a motion to approve and adopt Ordinance No. 1116 for assessment of delinquent sewer and trash bills. Councilmember Clemons seconded the motion.

- Councilmember Garvey and Finance Director Sanford discussed the number of citizens on the list and the change in the amount from the previous year.

## **Approval of Ordinance No. 1117**

Pursuant to Chapter 8, Health and Welfare, Section 7, Weeds of the Code of the City of Lansing, Kansas, a copy of Ordinance No. 1117 listing the account name, property address, and delinquent amounts for property owners who failed to pay weed removal fees is attached. Upon adoption by the City Council and subsequent publication in the Leavenworth Times, this Ordinance shall constitute a lien against the real estate for which service was supplied.

Councilmember Clemons made a motion to approve and adopt Ordinance No. 1117 for assessment of delinquent fees for weed removal. Councilmember Kirby seconded the motion.

Councilmembers Studnicka and Clemons discussed with Finance Director Sanford about the procedures and number of property owners associated with the weed abatement ordinance.

Approval of Resolution No. B-10-2024, Reinvestment Housing Incentive District

At the April work session, the City Council reviewed the idea of establishing RHID Districts throughout Lansing as a means to create more residential development that would be attainable for more residents. Establishment of the RHID does not cost the city money up-front. However, new property taxes generated in the district after construction can be rebated for up to 25 years back to the developer as a means to make housing more attainable. The city would come up with an agreement with each parcel/developer as to the timeline and percentage/rate of return. To begin, the RHID will identify six parcels:

- Fairway Estates Parcels (3) 1)
  - a. Main Parcel, 25.5 acres
  - b. Secondary Parcel, 16.9 acres
  - c. DeSoto Access Parcel, 1.9 acres
- 2) Fairlane Townhomes, 3.1 acres. Fairlane Townhomes, 1st Plat, Lot 1
- 3) Fawn Valley Parcel-8.52 acres. Fawn Valley South, 2nd Plat, Lot 5
- 4) City Property at West Mary & DeSoto-37.1 acres, Archdiocese Addition, Lot 2

Councilmember Robinson made a motion to approve and adopt Resolution No. B-10-2024 -A Resolution to create a Reinvestment Housing Incentive District. Councilmember Kowalewski seconded the motion.

- Council discussed with City Administrator Vandall and Economic Development Director Gentzler the process and stipulations of how the RHID would affect the city's development plans, negotiation capabilities for agreements, and taxing options for future developments.
- Councilmember Garvey asked City Administrator Vandall to clarify the number of properties associated with this application and how any additional properties would be added.
