MEETING MINUTES November 3, 2022

Call To Order:

The regular meeting of the Lansing City Council was called to order by Councilmember Brungardt at 7:00 p.m.

OLD BUSINESS:

Approval of Minutes of the Regular Meeting of October 20, 2022, as presented.

Councilmember Buehler made a motion to approve Regular Meeting Minutes of October 20, 2022, as presented. Councilmember Studnicka seconded the motion. No discussion took place. Roll Call Vote: Aye: Councilmembers Kirby, Majure, Garvey, Buehler, Clemons, Brungardt, Studnicka; and Trinkle Nay: none; Abstain: none; Absent: none. The motion was approved.

Re-appointment of Trade Boards of Appeals Members

- Building: Larry Hahn and Sean DeSouza

Councilmember Trinkle made a motion to approve the above-named to terms ending November 30, 2025. Councilmember Buehler seconded the motion. Roll Call Vote: Aye: Councilmembers Kirby, Majure, Garvey, Buehler, Clemons, Brungardt, Studnicka; and Trinkle Nay: none; Abstain: none; Absent: none. The motion was approved.

Bernard Park Batting Cage Change Order

At the October 20 City Council meeting a discussion was held about the possibility of adding a batting cage to the new baseball and softball complex. The batting cage would be a change order from the original plan. The cost to install the batting cage would be \$21,149.94 without power. If the city were to provide a power source near the batting cage, the total would be \$29,796.81

Councilmember Studnicka made a motion to approve the change order to add a batting cage with power for a total not to exceed \$29,796.81. Councilmember Kirby seconded the motion. Councilmember Buehler and Director Crum discussed the location of power source and logistics of how it would be run to the batting cage. Councilmember Garvey asked for clarification from Director Crum regarding the change in final total costs. Councilmember Garvey: Thanked the volunteers on the boards. Get out there and vote. Stated that he had discussed with the City Administrator regarding the pool and foliage surrounding the pool. Clarified that there will still be foliage around the pool if the vote passes.

Councilmember Buehler: Thanked the trade boards volunteers and congratulated the councilmembers that were recognized for their years of service. On this day in 1913, the United States Government implemented the federal income tax.

Councilmember Clemons: Thanked all the volunteers. Discussed with City Administrator regarding clarification from school district about hours for lap swim at the high school pool. Asked everyone to vote.

Councilmember Brungardt: Stated it was a right and a duty to vote.

Councilmember Trinkle: Thanked the volunteers for the trade board. Asked if any of the board members were new. The City Administrator and City Clerk affirmed that most of the people on the boards were previous board members. Get out and vote.
