# City of Lathrup Village Police Department - Monthly Summary

November 2025

11/2/2025 -

25-10177 – Mental Health Call

Officers were called to an LV home in response to a suicidal subject. Officers found the individual on the roof of the home and she made statements suggesting she wanted to cause harm to herself. Officers grabbed the subject off the roof, took her into protective custody, and sought a mental health evaluation for the subject.

11/3/2025 -

25-10191 – Found property

Officers found a drill in the road. It was collected and put into property for safe keeping.

25-10202 – Mental Health Call

Officers were dispatched to a home for an individual who recently had a change in mental status. The subject was highly agitated and the officers needed the assistance of the FD medics to calm the subject down and get to the hospital for evaluation.

25-10204 – ID Theft

An individual came into LVPD to report and identity theft. They had their cellphone compromised which compromised their google accounts which had access to sign into banking information. At the time, there was no monetary loss but the victim's cellphone was hacked intentionally with a clear intent to deprive the subject of access to their personal information. No follow up noted at this time.

11/4/2025 -

• 25-10226 – Suspicious

Officers were called to an LV residence where the reporting party had a broken vehicle window. There was nothing missing from the vehicle and there was no interior damage. It is believed a landscaping crew with a leaf blower accidentally blew debris, breaking the window. The report was made for insurance purposes.

11/5/2025 -

25-10309 – DWLS

An officer made a traffic stop and found that the driver was suspended. The driver was issued the appropriate citation.

## 11/6/2025 -

• 25-10346 – Fraud

A Lathrup resident reported that he purchased what he believed was a 2017 truck from an individual. When the paperwork was complete, the victim realized that the suspect had given him a 2014 truck which, according to the victim, was not worth the amount paid. At this time no follow up has been noted.

## 11/7/2025 -

• 25-10355 – OWI

An officer was alerted that a suspicious and damaged vehicle was stopped in the neighborhood. Upon contacting the driver, the officer realized they were under the influence of at least alcohol. After probable cause was established, the driver was placed under arrest for OWI.

## 11/10/2025 -

25-10458 – Trespass Warning

Officers were asked to trespass an individual from a Lathrup Village business.

Officers informed the individual of the trespass warning and gave her an opportunity to leave and even helped put gas in her vehicle so she could leave the premises and make it back home. The individual complied.

## 11/11/2025 -

25-10486 – DWLS, Warrant

Officers pulled over a vehicle which returned no record. The driver was suspended and had a warrant out of another jurisdiction. The driver was issued the appropriate citation, arrested on the warrant, and turned over to the nearby jurisdiction. The vehicle was impounded.

## 11/12/2025 -

25-10522 – DWLS, Warrant

Officers pulled over a vehicle that ran a stop sign. The driver was suspended and had a warrant out of another jurisdiction. The driver was issued the appropriate citation, arrested on the warrant, and taken to the nearby jurisdiction for booking. The vehicle was impounded.

## 11/13/2025 -

• 25-10564 – Family Trouble

Officers were called to an LV home for a report of people fighting outside. On arrival, the home was quiet. Officers spoke to the homeowner who said his children got into an argument and one of them left on foot.

## 11/14/2025 -

• 25-10577 – Animal Bite/Scratch

A witness came into LVPD to report a dog bite. The witness did not know who the victim was but did know where the owner of the biting dog lived. Officers were able to speak to the victim and owner of the dog. The victim did not want to press charges. Officers were able to get the appropriate information about the dogs' vaccinations and told them the dog must be quarantined for 10 days.

• 25-10585 – Fraud

An individual tried to pass a fraudulent check at a Lathrup bank. He was identified by the camera footage and his ID that he left at the bank. Currently, no follow up is noted.

• 25-10594 – Felony Warrant

Officers stopped a vehicle for an equipment violation. The driver had a felony warrant out of a nearby jurisdiction. The driver was taken into custody and taken to that jurisdiction for booking.

## 11/16/2025 -

25-10629 – UDAA

Officers were dispatched to a Lathrup home in reference to a stolen vehicle. The owner arrived home late at night and forgot to grab a bag out of the vehicle which had the keys in it. The vehicle was also unlocked. The vehicle was taken overnight. No follow up has been completed at this time.

25-10630 – MDOP/LFA

A Lathrup resident that their vehicle window was broken overnight. Initially, it was reported that nothing was taken but later the victim remembered that a work laptop was in the vehicle at the time and was now missing.

At this time, no follow up has been noted.

## 11/17/2025 -

• 25-10655 – Suspicious

A resident came into the station with their adult child about a suspected fraud. The child stated her mother has dementia and a roofing company came to the home and had her mother sign a roofing contract and then the financing company got her to sign. At this time, the report was categorized as civil.

## 11/18/2025 -

• 25-10688 – Home Invasion

A Lathrup resident reported that a known person who used to live with him broke into his home and stole expensive items from the home. The suspect stated she was currently living there but was there to retrieve items. No info yet about sending charges to OCPO.

## 11/19/2025 -

25-10740 – PDA

A driver reported that a vehicle had an unsafe load on their truck/trailer and items fell off it and struck the reporting persons vehicle causing damage. The officer was able to obtain the driver info but was unable to find vehicle or trailer information.

A resident came in to report that they had been scammed into sending a large amount of money in bitcoin to an unknown entity. At this time, no follow up has been noted.

• 25-10840 - A & B

A patron of a Lathrup Village business was physically assaulted by an employee of the business. The assault was captured by video at the business. The report was sent to OCPO for charges.

## 10/23/2025 -

• 25-10887 – PPDA

A resident found their mailbox on the ground. The officer discovered vehicle parts nearby and entered that information and photos into the report.

## 11/24/2025 -

• 25-10917 – PPDA

An individual reported that his parked vehicle had been sideswiped in the parking lot of a Lathrup Village business. Both parties opted to not involve insurance and the at fault party agreed to pay for damages. The owner of the damaged vehicle wanted to make a report in case the at fault party did not follow through.

• 25-10929 – Harassing communications

A Lathrup resident stated that a boy she was seeing was seeing harassing and controlling messages to her. Officers spoke with the individual and he stated that he blocked her and would no longer be contacting her.

## 11/26/2025 -

• 25-11021 – Suspicious

An officers pulled over a vehicle that had a license plate that returned with a stolen plate. Upon investigation, the driver and passenger had picked it up from a dealership and were taking it for a test drive. The vehicle was impounded for pick up by the owner and the driver and passenger were released.

• 25-11030 – Felony arrest warrant

Officers made a traffic stop and discovered that the driver had a felony warrant out of a nearby jurisdiction.

## 11/27/2025 -

• 25-11075 – OWI

An officer made a traffic stop and believed the driver to be intoxicated. Upon further investigation, the officer had probable cause to arrest the driver. He was booked and processed at Berkley and released hours later when sober.

## 11/28/2025 -

• 25-11101 – Suspicious

A parent from the University Academy came in to report that someone had taken her son's trumpet from the band room. She needed to make a report for insurance purposes.

• 25-11103 – Stolen Property

An individual dropped their wallet in the lot of an LV business. When she realized the wallet was gone, she went back and they provided footage showing her dropping

her wallet and a nearby vehicle pulling up next to her vehicle, getting out, picking up the wallet and leaving the scene. No follow up noted at this time.

## 11/30/2025 -

• 25-11174 – Mental health call

Officers were dispatched to an LV residence in reference to a mother needing assistance with her daughter. It was discovered the child needed a mental health evaluation and was taken to the hospital for same.
