01/02/2025 25-00061 Assist Other Law Enforcement Department

An Officer assisted the Port St Lucie Police Department in Florida in drafting a search warrant which was valid in Michigan. They were investigating a crime which occurred in their jurisdiction and their investigation lead to a suspect in our jurisdiction.

01/02/2025 25-00074 DWLS Arrest

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver had a suspended driver's license and an arrest warrant out of MSP for OWI. They were issued a citation for DWLS and turned over to an MSP Trooper who arrived on scene. The vehicle was turned over to a licensed driver.

01/05/2025 25-00175 Family Trouble

Officers responded to a residence for reports of a domestic disturbance. No evidence of an assault was found. One party agreed to leave for the night. Officers responded to the same residence the next day as well.

01/06/2025 25-00207 Family Trouble

Officers responded to a residence where there have been ongoing calls for family trouble between a husband and wife. It was determined that the argument was verbal only and one party decided to leave for the night to deescalate the situation.

01/08/2025 25-00287 Mental Health Call

Officers responded to a residence after being contacted by a suicide help line. They located the subject in question inside the home. The subject did indicate that they were suicidal. After a short struggle, they were taken into protective custody and transported to a local hospital for a 72 hours evaluation hold.

01/08/2025 25-00303 Operating While Intoxicated

Officers were dispatched to an area for a report of a slumped driver. They located the vehicle, and initiated a traffic stop after observing erratic driving. The driver was subsequently arrested for OWI. A search warrant for blood was obtained and the specimen collected at a local hospital. The investigation is awaiting those results.

01/10/2025 25-00367 Assault & Battery

Officers responded to reports of two men fighting in the middle of a major roadway. Upon arrival, both parties were gone. Through speaking with multiple witnesses, those subjects were identified and interviewed over the phone. It turned out to be a traffic altercation. The investigation is ongoing.

01/10/2025 25-00377 Domestic Violence A&B

Officers responded to a local business where a male and female were arguing loudly. There was no immediate evidence that a physical assault occurred so no action was taken. The report was sent to the Detective Bureau for further investigation.

01/10/2025 25-00379 Suspicious Circumstances

An Officer was called to a residence where a citizen saw a vehicle driving slowly by mailboxes. Officers found dozens of open mailboxes, some containing mail, others not. All residences with suspicious activity around their mailboxes were documented in case mail ended up missing.

01/10/2025 25-00384 Retail Fraud

Two suspects stole approximately \$550.00 worth of liquor from a local convenience store. Officers were able to obtain suspect information through biometric databases from surveillance photos. Officers also connected the suspects in multiple other thefts in other jurisdictions and are working with those departments currently.

01/11/2025 25-00420 OWI Arrest

Officers were in the back lot of LVPD preparing their patrol units for their shift when a vehicle entered the authorized vehicles only lot, proceeded through the lot and ran over the curb onto the grass area in front of City Hall. Officers ran to the vehicle and opened the door. After an investigation, the driver was found to be intoxicated. She was arrested for OWI and a search warrant for a blood draw was obtained. The results were received back and she was found to be at a .289 BAC.

01/12/2025 25-00443 UDAA (Vehicle Theft)

An Officer took a report of a vehicle theft from a residence. The vehicle was unlocked with the key fob inside. Officers tracked the vehicle through GPS to an address in Detroit and recovered it. The vehicle was processed for evidence and the investigation is still open.

01/12/2025 25-00447 DWLS Arrest

An Officer initiated a traffic stop for a stop sign violation. It was later determined that the driver had a suspended drivers license. They were cited and released from the scene with a misdemeanor citation for DWLS. Their vehicle was impounded.

01/13/2025 25-00462 Identity Theft

While investigating a fraud case, an Officer realized a resident who was unaware that they may be a victim of fraud. The Officer interviewed that subject and determined that they were. Another report was taken when an unknown subject applied for a Home Depot credit card in their name. They accrued thousands of dollars of charges on it before the victim realized it.

01/14/2025 25-00489 Distributing Child Sexually Abusive Material

Officers investigated an incident at the school where a 7th grader uploaded a sexually explicit photo of herself to her Instagram account and allowed other student to access it on their phones. One or more of the students began distributing it around the school. The students were interviewed and the phone was taken to evidence. The Oakland County Crime Lab is in the process of forensically dumping the phone for information and the investigation is ongoing.

01/15/2025 25-00514 Fraud

A resident reported that she was defrauded when she inadvertently provided private information to an unknown solicitation call. She sent the person \$2,000.00 through Zelle before she realized it was a scam. She later found that 3 of her credit cards had also been fraudulently used as well.

01/15/2025 25-00525 Assist Other Government Agency

Officers assisted Child Protective Services at a residence when they had a court order to remove a child from the home. The homeowner refused to allow anyone in the home. Without a warrant to enter the home forcibly. CPS and the Officers left the scene as the child was not known to be in immediate danger.

01/16/2025 25-00546 Family Trouble

Officers responded to a residence for a report of a domestic disturbance. The male party left prior to the arrival of Officers. Nothing physical had occurred. The incident was documented.

Officers responded to a local business when a woman called, claiming that the father of her child arrived, causing a disturbance. It was determined that the father just wished to speak to the mother because she was not answering his phone calls. There was no actual contact between the two and no crime had occurred. The father left without incident.

Officer responded to a residence where they were the night before with CPS attempting to removed a child from a home with a court order. This time, they had obtained a warrant to forcibly enter the home. Officers did so by forcing the front screen door open and were able to take possession of the child with some help from Berkley DPS Officers.

01/17/2025 25-00597 Possessing a Stolen Vehicle

An Officer initiated a felony stop on a vehicle which had been stolen a few days prior out of Detroit. The driver was detained, but later released pending the issuance of a warrant. It is believed that driver was the boyfriend of the owner and it was reported stolen after a domestic dispute. The report has been sent to the Oakland County Prosecutors Office for review.

01/19/2025 25-00691 PPO Service / Family Trouble

Officers responded to a family trouble. At the scene, Officers found that the male subject had an unserved PPO where the female subject was the protected party. The man was officially served the PPO and left the scene without incident.

01/20/2025 25-00716 Felony Arrest Warrant

An Officer initiated a traffic stop for a traffic violation. It was determined that driver had a felony warrant out of Canton PD. They were arrested on the warrant. The Officer met Canton PD where the subject was turned over to them.

01/21/2025 25-00753 Fraud

A resident reported that her debit card was used by an unknown suspect in the amount of approximately \$400.00. The suspect used it multiple times for Uber Eats. They were identified through the Uber Eats account and the investigation is ongoing.

01/22/2025 22-00792 Suspicious Circumstance

A local business owner was scammed out of \$5,000.00 when he received a call from a subject claiming to be from a loan office. He was requested to cash a check for \$19,000.00 when he receives it and then send back \$5,000.00 via gift cards. When he realized the \$19,000.00 was fraudulent, he had already sent the \$5,000.00. The incident was documented and being investigated further.

01/22/2025 25-00796 Aggravated Domestic Assault

Officers responded to a residence for a report of a domestic dispute. Upon arrival they found a chaotic scene where a father and daughter had been physically fighting. After restoring order, it was determined that the daughter was the aggressor and bit the father's hand, leaving a sever wound. She was arrested for aggravated domestic assault and transported to Berkley PD to await arraignment.

01/26/2025 25-00955 Operating While Intoxicated

An Officer found a vehicle on the sidewalk to City Hall, beeping its horn. When he approached the vehicle, he located a woman in the driver's seat, showing signs of intoxication. The woman was subsequently arrested for OWI. A search warrant for blood was obtained and a specimen taken. Results were received back from the crime lab indicating the subject had a BAC of .209 at the time of her arrest. The report was sent to the Oakland County Prosecutors Office for review of charges.

01/27/2025 25-00987 Drug Overdose

Officers responded to a local residence when a subject was reported to be found overdosed on narcotics. The subject was still alive when Officers found him and was transported to a local hospital for treatment.

01/27/2025 25-00996 Fraud

A resident reported that a Home Depot Credit Card was procured in her name and approximately \$2,400.00 in charges were accrued before she noticed it. She is not responsible for the charges according to Home Depot. This is being investigated as possible related to similar incidents which have occurred recently.

01/28/2025 25-01026 Threats to Commit Violence Against a School

Officers are investigating an incident where a student at a local school was found to have posted a photo on his Instagram account of the school and a caption indicating he was going to "blow up" the school. He was immediately removed from school. The cell phone was sent to the Oakland County Crime Lab for a forensic review. The student remains out of school until the investigation is complete.

01/30/2025 25-01113 Fraud

Officer took a report from a resident that was scammed out of \$5,700.00. They had been transferring money to an unknown suspect for months after being approached on Facebook for assistance. There is no suspect in this case as it likely originated overseas.

1/31/2025 25-01142 Welfare Fraud

A resident reported that an unknown suspect was using his EBT food stamp benefits. The victim was still in possession of his card. The State of Michigan was going to reimburse his account, but required a police report to do so.
