

City of Lathrup Village Police Department - Monthly Activity Summary

July 2024

07/01/2024 24-08750 Suspicious Circumstance

Officers responded to a bank where a female reported that she had been threatened by a former friend to give him money or he would kill her. Officers contacted both parties. It was determined that the reporting party could not keep her story straight and that no crime occurred. The incident was documented but no action was taken.

07/02/2024 24-08777 Animal Complaint

A resident reported that a dog left a property and almost attacked her and her dog while they were walking down the street. The dog in question did not bite or scratch, just barked and its license was up to date. The incident was documented.

07/02/2024 24-08778 Suspicious Circumstance

A victim reported that he had \$2,000.00 withdrawn from his account after he provided his personal banking information to a subject on the phone, who he believed to be an employee of a local bank. The withdrawals were made in Detroit and the victim was advised to also make a report there.

07/02/2024 24-08780 Accidental Property Damage

An incident was documented for insurance purposes when a large tree branch fell from a tree, damaging a resident vehicle.

07/03/2024 24-08830 Found Property

A citizen turned in \$226.00 they found on the street. There were also debit cards and an ID with the cash. Officers were unable to locate the owner by phone, but sent a letter to the address on the ID, advising them that LVPD was in possession of the property.

07/04/2024 24-08877 Fraud

A victim reported that she had \$1,000.00 withdrawn from her account after she provided her personal banking information to a subject on the phone, who she believed to be an employee of a local bank.

07/05/2024 24-08895 Misdemeanor Arrest Warrant

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver had a suspended driver's license and multiple arrest warrants out of Canton PD. They were cited with a misdemeanor citation for DWLS and transported to a neutral location to be turned over to Canton PD. The vehicle was impounded.

07/05/2024 24-08915 Assault and Battery

A former resident reported that she had been assaulted by her live-in boyfriend in August of 2022. She had not reported the incident at the time. The incident was documented, but the victim was unsure at the time of reporting it, if she wished to pursue charges.

07/05/2024 24-08924 DWLS Arrest

An Officer initiated a traffic stop for a stop sign violation. It was determined that the driver had a suspended driver's license. They were cited and released at the scene with a misdemeanor citation for DWLS. The vehicle was turned over to a licensed driver.

07/06/2024 24-08964 Mental Health Call

Officers responded to a local park after a female called stating that she was suicidal. The woman was transported to a local hospital where she wanted to undergo a mental health evaluation.

07/07/2024 24-08999 Fraud

A resident reported having multiple pending transactions on a variety of Apps on his phone, all through his Bank of America account after allowing an unknown person on the phone to have remote access to his phone. The victim found the number online, listed as a technical support number for a medical device he was having issues with.

07/07/2024 24-09004 DWLS Arrest

An Officer initiated a traffic stop for a stop sign violation. It was determined that the driver had a suspended driver's license. They were cited and released at the scene with a misdemeanor citation for DWLS. The vehicle was impounded.

07/09/2024 24-9058 Civil Matter

An Officer assisted in mediating an issue between VRBO and a renter after the renter arrived at the property to find it being rented to another individual.

07/10/2024 24-09088 DWLS Arrest

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver had a suspended driver's license. They were cited and released at the scene with a misdemeanor citation for DWLS. The vehicle was turned over to a licensed driver.

07/11/2024 24-09124 Assist Other Law Enforcement Agency

Officers assisted Michigan State Police in the locating, arrest and transport of 2 fraud suspects.

07/12/2024 24-09131 Assist Other Law Enforcement Agency

An Officer assisted the Pennsylvania State Police with drafting a search warrant on a local bank after a victim in Pennsylvania reported that a suspect had swindled them into transferring money to the suspect account at that local Lathrup Village bank.

07/13/2024 24-09160 Suspicious Circumstance

A citizen reported that a young girl, approx. 6 years of age, was walking alone on the side of a major roadway. Officers were unable to locate the girl, but later confirmed that the child was located by her grandmother and was safe at home.

07/15/2024 24-09224 Flee and Elude

An Officer attempted to stop a vehicle after realizing that the registered owner of the vehicle had multiple arrest warrants. The vehicle fled at a high rate of speed and the Officer eventually terminated the pursuit. The vehicle was found later with a new license plate. An Investigation found that the driver (registered owner) reported her plate as stolen within an hour of fleeing the Officer and received a new plate from SOS. The case has been submitted to the OCPO for a review of charges.

07/15/2024 24-09225 Larceny

A man reported having jewelry stolen from his home during an open house by his real estate agent. A list of people who entered the home was obtained and officers are investigating.

07/15/2024 24-09232 Trespassing

Officers responded to a residence where a woman was intoxicated and walked into her ex-husbands' home, attempting to see her children. The woman had an unserved PPO, which was then served to her by Officers. The woman still refused to leave after being warned about trespassing. She was eventually arrested for trespassing and resisting arrest. She was transported to Oakland County Jail due to her combativeness. She was eventually given a misdemeanor citation for trespassing and released.

07/16/2024 24-09215 Larceny from Automobile

A resident reported that their unlocked work vehicle was broken into during the night and their work bag was taken. Their bank information, which was in the bag, had been used to make several unauthorized purchases. The incident is under investigation.

07/18/2024 24-09345 Misdemeanor Arrest Warrant

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver had outstanding warrants out of Berkley PD. Berkley advised that they wanted the subject on the warrants. They were transported and turned over to BPD.

07/21/2024 24-09476 Misdemeanor Warrant Arrest

An Officer went to the Detroit Detention Center and took custody of a prisoner with an outstanding LVPD warrant. They were transported to Berkley PD to be processed and await arraignment.

07/22/2024 24-09478 Larceny of Mail

Officers were alerted when an alarm associated with the post office mail box was activated. Officer's arrived on location and attempted to contact 2 subjects walking nearby. The subjects fled on foot. A Royal Oak K9 and a Southfield PD drone were utilized, but the subjects were not located. The investigation was turned over to the Post Office Inspector General.

07/22/2024 24-09496 Civil Matter

A woman who recently sold a vehicle to a local used car dealer found out that the dealer had never taken the vehicle out of her name. The information was documented in case of future fraud related to the vehicle.

07/22/2024 24-09497 Uttering & Publishing

A citizen reported that a check which she placed in the LV Post Office Mailbox had been cashed for \$800.89 by a man who was not the original designee and the original amount had been changed. It was determined that the incident was not related to a recent mail theft from the LV PO Box. The incident is being investigated further by the jurisdiction the citizen lives in.

07/22/2024 24-09424 Civil Matter

An Officer mediated the return of \$1,000.00 which was reported by a victim to have been fraudulently swindled from him over a purchase on Facebook Marketplace.

07/24/2024 24-09560 Suspicious Circumstance

A man reported to a local bank that his ex-wife, who had recently been fired from the bank had made threatening comments to him about hurting her old supervisor at the bank. All parties involved were interviewed and it was determined that the threats were not credible but were fabricated due to a contentious custody battle between the two.

07/24/2024 24-09565 Operating While Intoxicated Arrest

An Officer initiated a traffic stop for a red-light violation. A subsequent investigation determined that there was probable cause to arrest the driver for Operating While Intoxicated. They were arrested and transported to Berkley PD for processing.

07/26/2024 24-09619 Home Invasion

A resident reported that his home was broken into overnight when he was not there. He reported that an antique clock worth approximately \$10,000.00 was taken. This investigation is ongoing.

07/28/2024 24-09670 DWLS Arrest

After an Officer responded to a property damage accident, they learned that one of the drivers had a suspended drivers license. They were cited and released on scene with a misdemeanor citation for DWLS. The vehicle was impounded.

07/29/2024 24-09689 Mental Health Call

Officers responded to a residence when a mother advised that her daughter is refusing to take her medication for schizophrenia and was acting very strange. She wished to have her committed for a psychological evaluation. The daughter refused to go and was taken into protective custody to be transported to the hospital. The mother completed the petition paperwork.

07/29/2024 24-09691 Fraud

A resident reported that over \$7,000.00 has been fraudulently withdrawn from her bank account in multiple transactions which she did not authorize. A search warrant was sent to her bank for information about who requested the withdrawals and the investigation is ongoing.

07/29/2024 24-09710 Hospice Death

An Officer responded to a residence when a hospice nurse advised that a 76-year-old female was found deceased. The scene was investigated and the proper paperwork was completed by the Officer. The Medical Examiner released the deceased to the family.

07/29/2024 24-09713 Larceny

A citizen reported that while at an ATM at a local bank, they were approached by a man who came out of the shrubs nearby. They left because they were scared. When they returned, they reported that their card was still in the machine, but the \$1,000.00 in cash was gone. The incident is still under investigation.

07/30/2024 24-09736 DWLS Arrest

An Officer initiated a traffic stop for an expired registration violation. It was determined that the driver had a suspended driver's license. They were cited and released on scene with a misdemeanor citation for DWLS. The vehicle was turned over to a licensed driver.

07/31/2024 24-09764 Hospice Death

An Officer responded to a residence when a hospice nurse advised that a 77-year-old male was found deceased. The scene was investigated and the proper paperwork was completed by the Officer. The Medical Examiner released the deceased to the family.

07/31/2024 24-09767 Fraud

A local law firm advised that a check that was issued to a client of theirs, and cashed back in December, was presented to a party store in Detroit, where a subject was attempting to cash it. It was determined that the check was stolen from the original payee at their residence in Detroit. They were advised to contact Detroit PD and the incident was documented.

07/31/2024 24-09776 DWLS Arrest

An Officer located a vehicle which was reported wanted for fleeing from Southfield PD. The vehicle attempted to avoid the Officer but it eventually stopped. The Driver had a suspended drivers license. He was cited with a misdemeanor citation for DWLS and turned over to SPD for questioning reference the flee and elude.
