RESOLUTION TO ENTER INTO AN AGREEMENT WITH THE MICHIGAN DEPARTMENT OF TRANSPORTATION FOR A TRAFFIC CONTROL DEVICE AT MARGATE AVENUE AND SOUTHFIELD ROAD

At a regular meeting of the City Council of the City of Lathrup Village, Oakland County, Michigan, (the “City”), held on the 19th day of August 2024.

Whereas, the mission statement of the Lathrup Village Downtown Development Authority is to create an accessible village center that brings life to our vibrant, diverse community, supporting economic development to assist businesses and property owners in the District by combining public and private resources to provide an attractive and pedestrian-friendly environment where residents and visitors enjoy a welcoming, attractive community.

Whereas, the Lathrup Village Downtown Development Authority was awarded a Michigan Department of Transportation (MDOT) Highway Safety Improvement (HSIP) Program grant for the installation of a High-Intensity Activated Crosswalk (HAWK) installation along Southfield Road between Margate Avenue and Kilbirnie Avenue; including controller and cabinet, mast arms, pedestrian pushbuttons, countdown pedestrian signals, backplates, culverts, concrete sidewalk, pedestrian refuge island, curb and gutter, curb ramps and permanent pavement markings; and all together with necessary related work.
