
AFFIDAVIT OF INTENT



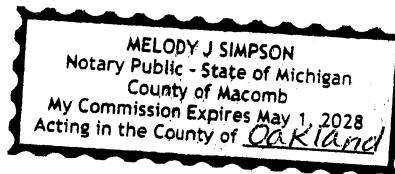
