April 2025

4/2/2025 -

25-3282 – UDAA

The victim's vehicle was taken by a friend who did not have permission to operate the vehicle. The victim was unable to contact the suspect after the vehicle was taken. The vehicle was entered into the LEIN system as stolen.

Follow up: later that day an officer was called back to the home because the vehicle had been found. The sister of the victim drove around the area where the suspect lives and found the vehicle in a gas station lot. The front tire had been shredded off the rim and the victim's sister stated that the black rim that is supposed to be on the destroyed wheel was changed to a silver rim. The vehicle was taken out of the LEIN system.

No other follow-up for charges is noted.

4/4/2025 -

25-3351/23-4811 – Misdemeanor Warrant

Officer was dispatched to Royal Oak PD to pick up on a Lathrup Village warrant. The arrestee was transported to Berkley for booking and processing and was released on bond.

4/5/2025 -

25-3395 – OWI

Officer was dispatched to I-696 in reference to a blocking vehicle. The officer found the vehicle and saw the driver asleep with the car still in drive. Once the driver was awake the officer conducted an OWI investigation and found probable cause to arrest the driver for OWI. The arrestee resisted arrest and continued to be uncooperative throughout the arrest process. The arrestee was housed at Oakland County.

4/7/2025

25-3476 – Suspicious/fraud

Individual came into LVPD front desk to report fraudulent activity on her credit card. The bank reimbursed the individual for the loss and began conducting their own investigation. The individual also reported getting letters saying they had unpaid parking tickets in Florida. The officer saw signs of a scam and

informed them to disregard the letters. The report was taken for documentation purposes.

4/7/2025 -

25-3470 – Assist citizen

Citizen came into LVPD to report her vehicle stolen. It was discovered the vehicle had been impounded by Southfield PD earlier that day while it was blocking the road unoccupied. The citizen received the release slip but asked officers to go to the tow yard to check it. There were no typical signs that the vehicle had been stolen. Their driveway also had no visible evidence to suggest the vehicle had been stolen.

No follow other follow up has been noted.

25-3467 – Assist medical

Officer dispatched to an unresponsive individual. On arrival, the officer assessed the situation and began CPR on the individual. The fire department arrived and took over control of the scene.

4/9/2025 -

25-3554 – Telephone used for harassment

Citizen came into the station to report a violent, threatening text message received from an acquaintance regarding a family member. The individual was scared and asked about the personal protection order process.

Follow up: Det. Spoke with the suspect who stated he was wrong and had heightened emotions at the time the text was sent. The suspect stated he and the family were talking and sorting the issues out.

4/11/2025 -

• 25-3605 – Forgery

A representative of the management company for a rented building in Lathrup Village made a report regarding a fraudulent rent check.

Follow up by DB: Det. contacted the suspect who eventually admitted she did not receive the check through proper channels. The charges will be sent to the prosecutor for review.

• 25-3601 - Forgery

A resident reported that a family member stole and cashed several checks in their name.

A follow up investigation report has been started but not resolved at this time.

4/18/2025 -

• 25-3810 – Misdemeanor Warrant

An officer made a traffic stop on a vehicle. The driver had a warrant out of Dearborn PD. The officer placed the individual under arrest and transported the individual to the meeting spot with Dearborn.

25-3818 – Assault

A domestic dispute occurred between a couple in a Lathrup Village business. It is alleged that the suspect struck the victim one or multiple times throughout the altercation. Video footage was obtained and will be reviewed by the detective. As children were present at the time of the incident a CPS 3200 form was completed.

4/23/2025 -

• 25-3997 – H&R

The at fault driver in a traffic crash left the scene of the accident after the fact. The other driver involved got the license plate and a good description of the driver. The officer was able to track down the hit and run driver, who was cited for the crash and leaving the scene.

25-4001 – DWLS

As the result of a traffic crash, the officer cited the at fault driver with DWLS.

25-4015/22-10567 – Misdemeanor Warrant

An officer was dispatched to meet Novi PD for a warrant pick up. The officer took custody of and transported the arrestee to Berkley PSD where the arrestee was booked and processed.

4/24/2025 -

25-4029 – DWLS

An officer made a traffic stop due to a suspicious temporary license plate on a vehicle. After investigation was clear the officer issued the driver for DWLS.

25-4031 – Illegal use of credit card

The victim filed a report stating that her credit card had been fraudulently used within the city of Lathrup Village.

Currently, no follow up is noted.

25-4039 – Recovered Stolen Vehicle

An officer came across what he suspected was a stolen utility trailer. Upon further investigation, it was confirmed stolen. The trailer was hauling a John Deere tractor as well. With assistance from the Oakland County Auto Theft, the officer was able to confirm that the tractor was also stolen. The investigation was turned over to auto theft.

4/25/2025 -

• 25-4069 – Aggravated assault

An officer was dispatched to a felony assault with a gun where it was reported the suspect pointed a gun at the victim. The victim got good info on the suspects vehicle and a description of the suspect. The suspect at one point had called dispatch to make a complaint, the officer cross referenced the vehicle information with the phone number that called dispatch to confirm the identity of the suspect.

Follow up by DB: The Lt spoke with the victim who positively identified the suspect. He later spoke with the suspect and told the suspect the report would be sent to the OCPO for review.

4/27/2025 -

25-4121 – OWI

Officer observed a vehicle driving erratically on the road (slowly, drifting over lanes, braking without reason). The officer continued to observe the vehicle driving in an unpredictable manner and initiated a traffic stop to investigate. Once pulled over the officer conducted an OWI investigation and found probable cause to arrest the driver for OWI. The arrestee was housed at Berkley PSD until sober.

4/28/2025 -

• 25-4154 – Felony Warrant Arrest

An officer made a traffic stop on a vehicle for disobeying a stop sign. The driver returned with a felony warrant out of Oakland County. The driver was placed under arrest and taking to Berkley PSD to await transport to Oakland County.

4/29/2025 -

25-4192 – DWLS

As the result of a traffic crash, the officer cited one of the drivers with DWLS.

• 25-4195 – Neighbor trouble

A resident came into the station to report an ongoing issue with a neighbor. Video footage was given to the Lt. and stored. No crime.

4/30/2025 -

• 25-4212 – Property Damage Accident

Details of a property damage accident were documented in a traditional report as both parties wished to deal with the crash between themselves. However, one party now wishes to document the incident in a crash report.

25-4214 – Trespass warning

An individual was patronizing a Lathrup Village business and an issue emerged between the individual and a representative of the business. The business wished for the officer to trespass the individual. The individual was told not to come back to the business and informed an arrest would happen if they were to return.

• 25-4215 – Identity theft

An individual came into LVPD to report identity theft. No report has been noted yet.
