Deadline to file as a write-in candidate is October 22, 2021 before 4:00 p.m. in the City Clerk's office the Declaration of Intent form. The forms are available in the City Clerk's office during business hours 8:00 a.m.-4:30 p.m. Monday – Friday. The form has to be notarized but if you have the form notarized in the Clerk's office there is a \$10.00 fee.
