

City of Lathrup Village Police Department - Monthly Activity Summary

June 2021

06/01/2021 21-4943 PPO Service

Officers served a Personal Protection Order to a subject while a custody exchange was being conducted at LVPD.

06/01/2021 21-4947 Threats and Harassment complaint

Employees of a local banking institution made a report to Officers after they were threatened and harassed by a disgruntled customer. The customer became irate at the employees while inside the bank, but left when she was asked to. She later contacted them by phone making vague threats.

06/02/2021 21-4971 Contempt of Court Arrest

Officers responded to a local business where a male and a female were arguing. After an investigation, it was determined the male half had a bond condition from an arrest in Romulus, he was not to have contact with that female. The subject was arrested and found to be carrying an unregistered firearm. The subject was processed at Berkley PD and Romulus PD arrived shortly after to take the subject into custody. The firearm was placed in property until registration could be proven.

06/02/2021 21-4973 Intelligence Information

After Officers arrested an armed subject for violating bond conditions at a local business, the victim provided information to Officers that the subject was involved in a shooting, in a neighboring jurisdiction, at a previous date. The information was provided to that jurisdiction for investigation.

06/03/2021 21-5003 Customer Trouble

A local business manager called Officers due to a conflict with a disgruntled customer. The encounter happened the previous day and was thought to be resolved, however, the manager stated that she later had a traffic altercation with the same woman. A report was taken, and

the manager was advised to go to Southfield PD if she wished to make a report about the traffic altercation due to it happening in that jurisdiction.

06/03/2021 21-5007 Fraud

A resident came in to make an informational report about fraudulent activities which were found associated with his bank account. The fraud originated overseas. The bank required a police report in order to reconcile the account.

06/03/2021 21-5008 Found Property

The Oakland County Road Commission called Officers to their work site to turn over 2 wallets which were found in the weeds next to a major road. OCRC was able to contact one of the owners and they came to LVPD to retrieve their property. The second wallet was placed in a property locker and attempts are being made to contact its owner.

06/04/2021 21-5049 Flee and Elude Vehicle

An Officer attempted to stop a vehicle which he recognized had fled from him 2 times previously. The vehicle fled again and the Officer terminated the pursuit when it left the City. The same vehicle would flee from Officers again on 06/08/2021. During this pursuit the driver was able to display his middle finger, out of the sunroof, to the Officer.

06/04/2021 21-5051 Assist other Law Enforcement Agency

An Officer assisted Southfield PD unit on a traffic stop when the vehicle stopped in LV and the Officers requested assistance. Two of the subjects in the vehicle were arrested for Receiving and Concealing Stolen Property and one as a Parole Absconder. A LV unit transported one of the arrestees to SPD upon their request.

06/04/2021 21-5053 Assist Medical

Officers responded to a local restaurant where a subject has passed out in his vehicle while waiting for his order to be completed. He was treated by SFD on scene and transported to a hospital for treatment. It was determined that drugs or alcohol were not a factor.

06/05/2021 21-5064 Neighbor Trouble

An Officer took a report that a neighbor had ran over a plastic grass edging. There had been apparent threats made on the part of both parties after the incident. The Officer spoke to both parties. The neighbor agreed to fix the damage and both parties agreed to keep the peace.

06/06/2021 21-5079 Suspicious Circumstance

Officers responded to an alarm at a local business and found a door which appeared to have been forced open. The business was searched but nothing was found. The next day, other Officers contacted the business owner and confirmed that the door had simply been left open, and no B&E had occurred.

06/06/2021 21-5088 Domestic Assault & Battery

Officers took a delayed report that there had been an altercation between 2 subjects who had a child in common. The incident had occurred on an earlier date in the City. Both parties were contacted separately, both provided statements, which were contradictory. The report was turned over to the detective bureau for review.

06/07/2021 21-5122 MDOP

Officers took a report that an ex-girlfriend threw a brick through a resident's window after he refused her entry into the home. Officers would later take an additional report when it was believed that the ex had keyed the man's vehicle.

06/07/2021 21-5124 Found Property

A cell phone was turned in which was found in in the City by a resident. It was discovered that the phone belonged to another resident. They were located and the property was turned over to them.

06/07/2021 21-5126 Fraud

An Officer took a fraud report of an unknown subject who solicited money from a resident via Twitter, using a Cash App. The subject posed as an old friend from high school. It was later determined the old friends account had been hacked.

06/07/2021 21-5130 Assist Citizen

An Officer was called to the area of a residence which Officers have been doing frequent checks due to a PPO against a resident's ex-husband who is volatile and dangerous. She was concerned about a vehicle which seemed to be on her street often, observing activity. The Officer contacted the vehicle which turned out to be a Private Investigator, looking into an unrelated insurance fraud case.

06/08/2021 21-5162 Flee and Elude Vehicle

An Officer attempted to stop on a vehicle which he had noticed had fled from him 3 times previously in the last few weeks. The vehicle fled again and the chase was terminated when it left the City borders.

06/09/2021 21-5197 Felony Arrest Warrant

An Officer initiated a traffic stop for a vehicle which has no plate. After an investigation, the driver of the vehicle had an extraditable warrant out of Ohio for Felony Fraud. Ohio advised they wanted to subject and he was transported to Oakland County Jail to await extradition. Evidence of check fraud was located during the vehicle search and it was TOT the detective bureau for further investigation.

06/10/2021 21-5210 Suicidal Subject

Officers responded to a report of a suicidal subject who was found pointing a gun to his head by his son. The gun was secured and Officers eventually persuaded to go to the hospital voluntarily for a psychological evaluation.

06/10/21 21-5224 MDOP

An Officer responded to take a report that a resident's ex-girlfriend had keyed his vehicle while in his driveway. A previous report was made when the ex had thrown a brick through the front window of his home.

06/10/2021 21-5234 Medical / Narcan Success

Due to proximity to the city and the risk of potential loss of life, Officers responded to a Southfield medical run near our border where an overdose caused a subject to be unconscious and not breathing. LVPD Officers arrived and removed the subject to a safe location. They administered 2 doses of Narcan, and an arriving Southfield unit then administered a 3rd dose. SFD arrived shortly after, and administered an intravenous dose. The subject started breathing, regained consciousness and was taken to the hospital for treatment.

06/11/2021 21-5247 Assist Child Protective Services

Officers received a tip from Child Protective Services, which stated that a juvenile was self-reporting that he was being abused, but refused to give his location. The email was pinged to a local address. Officers investigated this report. It was unfounded at the Lathrup Village address.

06/12/2021 21-5272 Personal Injury Crash

Officers responded to a report of a cyclist who was lying in the roadway, unconscious, with an apparent head injury. The subject has hit a curb near on intersection while driving an electric bicycle and was thrown from the vehicle. He was transported to the hospital for treatment. His electric bicycle was returned to his residence in Lathrup Village.

06/13/2021 21-5299 DWLR Arrest

An Officer initiated a traffic stop for a speeding violation. It was determined that the driver of the vehicle had a revoked license for having 5 or more alcohol related offenses. He was issued a citation for DWLR citation and released on scene. The vehicle was turned over to a licensed driver.

06/14/2021 21-5346 DWLS Arrest

An Officer initiated a traffic stop for littering when he observed a man throw an object out of his window. It was determined that the driver had a suspended license and the vehicle was not registered. The subject was cited for DWLS and released on scene.

06/14/2021 21-5348 Found Property

While checking an alarm at a local business, Officers located an unopened package from FedEx lying in a parking lot. It was found that the subject who it was addressed to lived just outside of the City in Southfield. Officers located him and turned over the package.

06/15/2021 21-5376 Assist other Law Enforcement Agency

Officers assisted Southfield Tactical units in conducting a felony stop on a stolen vehicle after the vehicle travelled into the City of Lathrup Village jurisdiction.

06/15/2021 21-5379 Obstruct Police / DWLS

An Officer initiated a traffic stop on a vehicle for not having a license plate attached. The driver initially gave a false name to hide the fact that his license was suspended. He was cited for driving on a suspended license and misrepresentation (Obstruction) and released on scene.

06/16/2021 21-5407 Larceny of signs

Officers responded to a local business where their security observed a woman steal an advertising sign from the business grounds. The woman was confronted and the sign was returned. The security guard observed multiple other signs from other businesses inside the woman's vehicle.

06/17/2021 21-5447 Family Trouble

Officers responded to an argument in the driveway of a residence between a boyfriend, girlfriend, and the girlfriend's father. During the argument, the boyfriend punched his own windshield and broke it. The boyfriend and girlfriend left prior to Officers arrival and no action was taken.

06/17/2021 21-5450 Gas line break

Officers responded to a residence where a gardener cut a large gas line just under the gas meter attached to the residence. Officers advised SFD and Consumers energy and promptly evacuated the homes in the vicinity. Consumers arrived a short time later and fixed the line.

06/17/2021 21-5458 Possession w/ Intent to Deliver Narcotics

Officers conducted a traffic stop for a stop sign violation. Upon further investigation, it was revealed that the driver did not have a license and the license plate on the vehicle was improper. While conducting an inventory search for impounding the vehicle, multiple small bags of marijuana were located within close proximity to cash money. The driver was subsequently arrested for driving with no license and possession with intent to deliver.

06/18/2021 21-5477 Elder Abuse / Fraud

A resident came into LVPD to report that her grandson had stolen over \$60,000 from her bank accounts by a few different means. The grandson has been out of state and his whereabouts are unknown. An initial investigation has been conducted and this case has been turned over to the detective bureau.

06/21/2021 21-5547 Suspicious Circumstance

A resident reported that her son had not been heard from in a week. The last she had heard from him was that he was going to move to an unknown City in Ohio. She reported him missing. Officers were able to locate the subject and verify that he was okay. His mother was advised.

06/21/2021 21-5551 Family Trouble

A resident came into LVPD to make a report that her daughter left home voluntarily after an argument and that she has not returned for 3 days. The resident located her daughter at work and verified she was okay, but she still refused to come home. The next day, the mother came in to report that her daughter did return home.

06/23/2021 21-5597 OWI Arrest

Officers observed a vehicle stopped at a green light on Southfield Rd. Officers contacted the vehicle's driver and found the subject to be exhibiting signs of intoxication. Field Sobriety Tests were conducted and the driver was subsequently arrested for Operating While Intoxicated. During the incident, the driver threatened the Officers multiple times including stating that they would show up at their personal residences. The case is open pending blood results.

06/24/2021 21-5630 Neighbor Trouble

Officers responded to a residence where there was dispute between two neighbors. This is an ongoing issue with these two neighbors which has resulted in many complaints including multiple MDOP reports, noise complaints and a shooting. This particular complaint was unfounded.

06/25/2021 21-5655 B & E of a Business

Officer responded to a local restaurant that was broken into and the cash register was broken into. This break in was of the same MO of another BE discovered just afterward (21-5656). An investigation was conducted and a suspect description was obtained. The investigation is ongoing.

06/25/2021 21-5656 B & E of a Business

Officer responded to a local restaurant that was broken into and the cash register was taken. The register was recovered a short distance away by Officers, in front of a residence. This break in was of the same MO of another discovered just before (21-5655). An investigation was conducted a suspect description was obtained. The investigation is ongoing.

06/25/2021 21-5671 Attempt Suicide

Officers responded to a residence where reports of screaming and crying were coming from. Officers discovered a female subject with abrasions on her neck and she was very upset. After an investigation it was determined that the female had attempted to hang herself, but was found at the last moment by her husband who cut her down. The woman was transported to a local hospital for a psychological evaluation. CPS was also contacted due to other conditions found on scene.

06/26/2021 21-5686 Assault / Mental Health Call

Officers responded to a local group home where a resident assaulted a worker. The worker was treated on scene and the resident was transported to a local hospital where a psychological evaluation could be conducted.

06/28/2021 21-5736 Felony Arrest Warrant

Officers responded to a report of a man down in the parking lot of a local restaurant. After contacting the man, and having FD medically evaluate the him, it was determined that the man had a Felony Warrant out of Detroit PD. Officers arrested the subject and transported him to Detroit Detention Center per DPD.

06/29/2021 21-5760 Mental Health Call

Officers responded to a residence where a subject was threatening suicide. Officers contacted the subject and convinced her to seek help. The subjects spouse drove them to the hospital for a psychological evaluation while officers followed.

06/30/2021 21-5776 DWLS Arrest

Officers conducted a traffic stop for an expired plate violation. It was also determined that the vehicle had no insurance. The vehicle was impounded and the driver was issued a misdemeanor citation for DWLS and released on scene.

06/30/2021 21-5797 Strong Armed Robbery

After a dispute over payment for services at a local salon, a fight broke out between the patron and the salon worker. The fight resulted in injuries to the patron and damage to her vehicle. Also, during the fight, the salon worker ripped off the patron's necklace and fled the scene. An investigation is on-going.

06/30/2021 21-5799 Peace Officer Duties

Officers assisted two parties with a custody dispute in the lobby of LVPD. No action was taken other than documenting that the parenting arrangements were not being adhered to.

06/30/2021 21-5800 Larceny from Auto

Officers responded to a local residence where a landscaper discovered multiple pieces of lawn equipment were stolen from the bed of his truck. An investigation was conducted, but at the time the report was written, there are no suspects.
