They anticipate getting out grant information in February/March. DDA submitted an application to GM match on Main grant for \$50,000. We should have answers by the end of February. Other funding sources that will be pursued are T-Mobile Hometown, DNR Recreation Passport, and Ralph C Wilson grants.

## B. 2024 Alley & Approach Recommendation

Project was discussed at the December workshop. Bids went out the beginning of January and are due February 8. February 16 meeting, contract will be rewarded.

## C. Southfield Road Improvement Project - RAISE Grant

City, RCOC, and Southfield were awarded a grant writer by SEMCOG to write the RAISE grant application. A letter of support from the DDA and the City indicating our support and a commitment to fund the project is needed. A draft letter needs to be submitted by February. If successful, construction will take place in 2027. Estimated Lathrup Village match is \$3.5 million; additional support being sought.

## D. 2024 National Main Street Conference

Stec shared that Main Street Conference will be May 6-9, 2024 in Birmingham, Alabama.
