

## **City of Lathrup Village Police Department - Monthly Activity Summary**

### **February 2022**

02/01/2022 22-01196 Assist Citizen

Officers responded multiple times to a local residence after the homeowner reported having a man, living in the vents of her home, cyber stalking her. Multiple suspicious claims were made by the resident. All were investigated by Officers and were deemed to be unfounded. The resident had previous been seen for a psychological evaluation and was found fit to be able to care for herself, providing she takes her medications.

02/02/2022 22-01233 Abandoned Vehicle

An Officer responded to impound a vehicle which was found by a homeowner to be parked and left on his property for an extended period of time. The owner was unable to be contacted.

02/03/2022 22-01288 Abandoned Vehicle

An Officer impounded a vehicle at the request of a local business after the owner failed to return to remove it for an extended period of time. A 48-hour tag was affixed to the vehicle prior to it being towed.

02/05/2022 22-01364 Family Trouble

An Officer was called to a residence where the 29-year-old son was threatening to assault and kill his parents. He destroyed items all over the home. The son was extremely agitated when talking with Officers. The parents refused to write statements or press charges. The parties agreed to separate for the evening and the son agreed to move out. (See related CR# 22-2125)

02/05/2022 22-01388 Family Trouble

Officers responded to a verbal domestic argument. One party broke out a window to the home that they both live in. The parties agreed to separate for the night. One party was driven to a local hotel. No other police action was taken.

02/06/2022 22-01410 Suspicious Circumstance

A resident made a report of finding footprints outside of his home from the night before. Surveillance video from another nearby home showed an unknown vehicle pull up, and an unknown subject get out and walk around. Nothing was taken or disturbed.

02/07/2022 22-01450 Suspicious Circumstance

Officer stopped a vehicle which had caused multiple people to call 911 due to its erratic behavior. Officers discovered the man to be very tired and falling asleep at the wheel. No drugs or alcohol were suspected. The man arranged for a ride home.

02/07/2022 22-01452 Larceny from a Vehicle

An Officer took a report from a resident who stated that their catalytic convertor was stolen off of their vehicle in their driveway. Surveillance video showed a man cut the power to their security lights and cut out the convertor from under the car. This has been turned over to the detective bureau.

02/08/2022 22-01484 Welfare Check

Officers responded to a home to check on a juvenile after friends from school indicated she may want to harm herself. Officers spoke to the juvenile, who admitted to trying to hurt herself previously and was having difficulty lately with her feelings. She agreed to go to a local hospital for a voluntary psychological evaluation.

02/08/2022 22-01496 Suspicious Circumstances

A resident came into LVPD to make a report of a suspicious circumstance. Their home was placed up for rent on the Zillow website. They stated that the home is not for rent and is unsure why anyone would do this.

02/09/2022 22-01547 Intimidation & Threats

An Officer took a report of intimidation at a local business. A confrontation between two patrons escalated into yelling back and forth and a possible shove. One party was still present

at the scene and the other was reached via telephone. The incident was documented and sent to the Prosecutors Office for review, but was denied.

02/09/2022 22-01556 DWLS Arrest

An Officer initiated a traffic stop for a stop sign violation. It was determined that the driver had a suspended driver license and children in the vehicle were not in car seats, as their age and size required. The driver was cited for DWLS and child restraint violations. Another driver came to the scene with car seats to transport the children. The vehicle was impounded.

02/10/2022 22-01582 Breaking and Entering – Business

An Officer, while on Patrol, noticed the front door of a business smashed in, but the security gate behind the door was still intact. The business was connected to a Pharmacy next door. The scene was processed for physical evidence but no suspects were developed.

02/11/2022 22-01632 Traffic Complaint

A subject came into LVPD to attempt to make a crash report for an accident that occurred 75 days prior. It was documented but a crash report was not filed due to the time that had passed and only one party being cooperative.

02/13/2022 22-01705 DWLS Arrest

An Officer initiated a traffic stop for a defective equipment violation. It was determined the driver had a suspended license. The driver was cited and released at the scene with a citation for DWLS, defective equipment and expired plates.

02/13/2022 22-01708 Assist other LE Agency

An Officer handled a crash on the expressway when the State Police requested assistance due to an 18 vehicle crash they were handling.

02/14/2022 22-01748 Fraud

A resident was frauded out of approximately \$10,000.00 by a man she believed to be from AT&T. She purchased gift cards and relayed the card numbers to the man. A report was taken and the case was turned over to the Detective Bureau for review.

02/14/2022 22-01752 Felonious Assault w/ Gun / Domestic

Officers responded to a residence where a caller stated that her girlfriend pointed a gun at her and threatened to kill her. Officers arrived and entered the home. Contact was made with the victim. The suspect had fled. While interviewing the victim, the suspect reentered the home. The suspect was subsequently arrested. The case was sent to the Oakland County Prosecutors Office for review.

02/15/2022 22-01763 No Operators License Ever Acquired

An Officer initiated a traffic stop for an improper lane use violation. It was determined that the juvenile driver did not have a license. The parent of the juvenile was called and they were turned over to that adult. A citation was not issued.

02/15/2022 22-01778 Fraud / Phone Scam

A resident reported that he received a suspicious call from someone claiming to be from Medicaid. Medicaid confirmed for him that this was a fraudulent attempt to obtain the residents personal information.

02/16/2022 22-01808 Assist other Law Enforcement Agency

An Officer assisted Southfield PD, briefly, with a vehicle pursuit of a suspect who had just been involved in a shooting. The Officer terminated the pursuit after the chase left LV jurisdiction.

02/16/2022 22-01625 Misdemeanor Arrest Warrant

An Officer initiated a traffic stop for a red-light violation. Upon further investigation, the driver of the vehicle had an outstanding warrant for Domestic Violence out of another jurisdiction. The driver was taken into custody by Officers and transported to meet the jurisdiction which held the warrant.

02/17/2022 22-01861 Fraud

A resident came into LVPD to report that she had been the victim of a romance scam. She met a man on a dating app and after talking to him for a couple of weeks, sent him \$4000.00 to help him out. The man then stopped contacting her. She had realized she had been scammed and contacted police.

02/20/2022 22-01973 Felony Arrest Warrant

An Officer initiated a traffic stop after identifying the driver from personal knowledge. The driver had a felony warrant out of another jurisdiction for a shooting. The driver was uncooperative, but was eventually taken into custody. He was then later transported to be turned over to the jurisdiction holding the warrant.

02/20/2022 22-01977 Receiving/Concealing Stolen Vehicle

An Officer initiated a felony stop after running the license plate and finding the vehicle to be stolen out of Detroit. The driver was arrested and brought to Berkley for processing. He was later released pending approval of charges. Detroit PD was contacted and given additional information, found in the vehicle, for a second suspect.

02/21/2022 22-02008 Suspicious Circumstance

Officer responded to take a report that a license plate was stolen off of a vehicle. After contacting the suspect, who was the reporting party's boyfriend, it was determined that the plate was not taken, and later found in the yard. It appeared to be a verbal domestic situation. No police action was taken.

02/21/2022 22-02013 Suspicious Circumstances

An Officer initiated a felony stop on a vehicle when the registered owner was found to have a felony warrant out of another jurisdiction for receiving a stolen vehicle. The subject was detained and that jurisdiction was contacted. There was some confusing in reference to the case, so the subject was advised and released. He was also instructed to contact the department which holds the warrant to clear up the confusion.

02/21/2022 22-02020 Expired License Misdemeanor

An Officer initiated a traffic stop for a stop sign violation. It was determined that the driver had an expired license. They were cited and released on scene for driving with an expired license. The vehicle was not towed due to extenuating circumstances.

02/22/2022 22-02048 DWLS Arrest

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver had a suspended driver's license. They were cited and released at the scene with a citation for DWLS. The vehicle was impounded.

02/22/2022 22-02075 Fraud

A resident came into LVPD to make a report that his identity had been stolen. Accounts were opened up with his name and identifiers at Wells Fargo and T-Mobile. A report was taken and turned over to DB.

02/23/2022 22-02125 Assault on Police Officers / Committal

Officer were given a court order to transport a 29-year-old man to Common Ground for a Psychological evaluation. Officers attempted to reason with the man for an extended period of time, but received only threats and posturing in return. When Officers attempted to take the man into protective custody, he fought with police and actively resisted, causing much damage to property within the home. Two Officers received minor injuries. The man was taken to Common Ground where he was turned over to staff. The report was sent to the Oakland County Prosecutors Officer for review of possible criminal charges. (Related CR# 22-1364)

02/23/2022 22-02138 Missing Juvenile

Officers located a juvenile, who was reported missing earlier by Dearborn Heights PD. The subject's parents were contacted and they arrived at the scene to retrieve their daughter. An investigation revealed that the daughter was at the residence voluntarily and no other police action was taken.

02/25/2022 22-02222 Customer Trouble

Officers responded to a residence where a Door Dash driver ran over the resident's lawn. The resident had previous filed a complaint with Door Dash after the same driver ran over his lawn

on a different date. They were advised that since there was no intent to damage the property, it was a civil matter.

02/26/2022 22-02252 Found Property

A subject found a wallet in the parking lot of a local bank. He attempted to return it to the owner over social media, but the owner accused him of stealing it. The wallet was turned into LVPD and Officers attempted to contact the owner. He was not initially contacted therefore the wallet was entered into property for safekeeping.

02/26/2022 22-02277 DWLS Arrest

An Officer initiated a traffic stop on a vehicle in which the driver fell asleep at a traffic light. Field Sobriety tests were conducted but it was determined that alcohol was not a factor. The man stated he had a medical condition in which his medication causes him to be drowsy. The man was cited for DWLR, as his license was revoked. He was allowed to leave his vehicle at a gas station and was given a ride by Officers.

02/27/2022 22-02284 Family Trouble

Officers were called to the side of a major road for reports of subjects fighting. It was determined that the argument was verbal only. All of the occupants in the vehicle either were intoxicated or did not have a valid license. A friend was called to pick them up.

02/27/2022 22-02300 DWLS / Private Property Crash

An Officer witnessed a private property traffic crash at a local business. Upon further investigation it was determined that the at-fault driver had a suspended drivers license. He was cited and released on scene for DWLS. A crash report was completed as well.

02/27/2022 22-02306 Animal at Large

A resident turned in a loose dog to LVPD after he found it near his home. There was no collar and no microchip found in the dog. The dog was transported to the Oakland County Animal Shelter.

02/28/2022 22-02340 DWLS Arrest

An Officer initiated a traffic stop for a speeding violation. It was determined that the driver had a suspended license. They were cited and released on scene for DWLS and speeding. The vehicle was not towed due to extenuating circumstances.
