# <u>City of Lathrup Village Police Department - Monthly Activity Summary</u>

## **August 2021**

08/02/2021 21-6629 DWLS Arrest

A traffic stop was initiated for an expired license plate offense. During the investigation, it was determined that the driver had a suspended drivers license. A misdemeanor citation was issued to the driver for DWLS. He was released at the scene, per new state laws.

08/02/2021 21-6632 Flee and Elude Police

An Officer was conducting an investigation during a traffic stop. After not being able to identify the driver the Officer walked back up to the vehicle. The driver then fled the scene in the vehicle. While attempting to flee, the vehicle struck a parked car in the parking lot. An accident report was also taken.

08/05/2021 21-6723 Trespass Warning

A subject who had her accounts frozen at a local bank due to fraudulent activity, came into the bank, causing a scene and refused to leave. Officers arrived and gave the subject a Trespass warning for the business.

08/05/2021 21-6725 Larceny from an Automobile

An Officer took a report that a catalytic convertor was stolen from a work truck, which was parked at a local business overnight. There are no suspects in this case.

08/05/2021 21-6727 Illegal Dumping

An Officer took a report that someone had illegally dumped construction debris in his yard. No video evidence or other physical evidence existed. There are no suspects in this case.

08/05/2021 21-6737 Accidental Property Damage

Officers took a report of accidental property damage. A truck carrying drywall on top of it, lost a portion of the load, which struck the vehicle behind it. The driver as given a citation for unsafe load.

08/06/2021 21-6745 Found Dog

A stray dog was found by a local resident. After speaking with Officers, the resident decided to foster the dog until its owner could be found. There were no lost dogs reported matching the description of this one.

08/07/2021 21-6771 Family Trouble

Officers responded to a report of a Domestic situation in the front yard of a residence. After an investigation, it was determined that both parties damaged property belonging to the other. The mutual combatants wrote out statements and both were unsure if they wished to press charges. No arrests were made, and the report was sent to the DB for review and possible submittal to the Oakland County Prosecutors Office.

08/09/2021 21-6809 Sudden Death – Natural

Officers responded to a report of a man found on the floor, with shallow breathing. The man was deceased when Officers arrived. Due to a few suspicious circumstances found at the scene, the Oakland County ME Investigator was summoned for an investigation. They continue to work with Officers on the case.

08/10/2021 21-6844 Assault and Battery

A subject came into LVPD to report that he had just been assaulted at a local hair dresser. He stated that the hairdresser belittled him because he told him that he was straight. When the hairdresser would not leave the issue alone, the victim raised his voice, causing the hairdresser to physically assault him while kicking him out of his business. Follow up was conducted at the place of business, but it was closed and no one was around.

08/11/2021 21-6865 Felony Arrest Warrant

Officers responded to Dickerson Facility of the Wayne County Jail system in Hamtramck and took custody of a prisoner who had 3 active arrest warrants out of LV. The prisoner was transported to Berkley PD where they were processed, and bonded out on the charges.

08/11/2021 21-6876 Civil Matter

An Officer took a report for documentation purposes only, from a subject who was having issues getting her children from her ex-husband during her allotted parenting time. This has been an on-going issue. Officers have had to testify in civil court in another jurisdiction in reference to this issue.

08/13/2021 21-6957 Larceny from an Automobile

Officers responded to take a report of a stolen temporary license plate. A valid Texas temporary plate was taken from a truck, which was parked on the street. There are no suspects.

08/15/2021 21-7002 Traffic Complaint / Vehicle Impound

An Officer initiated a traffic stop after seeing that a vehicle was driving down a main road on just a sparking rim. The driver was unaware of the problem. The vehicle was towed until it can be repaired.

08/15/2021 21-7010 Mental Health Call

An Officer responded to a residence to do a welfare check after learning the resident had not been heard from since they lost power. During a conversation with the resident, the Officer learned that the subject was having suicidal ideation. He was transported to a local hospital for evaluation.

08/15/2021 21-7012 Suspicious Circumstance

A resident came into LVPD to report that someone was using his gazebo during the night and left a candle burning inside when they left.

08/16/2021 21-7035 Domestic Violence

An Officer was dispatched to a residence where a boyfriend had assaulted his girlfriend by choking her, punching her, slapping her and threatening to kill her and her disabled father. He left on foot prior to the arrival of the Officer. The area was checked but he could not be located. He was identified and a warrant request was sent to the Oakland County Prosecutors Office for review.

08/16/2021 21-7050 Larceny from an Automobile

A resident reported that his vehicle was broken into overnight. A laptop and a bottle of prescription drugs were taken. There was no physical evidence and no suspects have been developed.

08/17/2021 21-7056 Misdemeanor Arrest Warrant

Officers responded to Macomb County Jail and took custody of a prisoner who had an outstanding warrant out of LVPD. They were transported to Berkley PD for processing and were released after they posted their bond.

08/17/2021 21-7063 Mental committal

A subject at a local bank made comments about wanting to harm herself. Officers responded and were told the same thing by the subject. She was transported to a local hospital where she checked herself in for a psychological evaluation.

08/17/2021 21-7068 Fraud

A resident reported that there were fraudulent charges attributed to her checking account with a local bank. The bank is investigating. They needed the report for documentation purposes only.

08/19/2021 21-7094 Identity Theft

A resident came into LVPD to report that his identity was stolen and used to open a fraudulent DTE account.

08/19/2021 21-7109 Family Trouble

Officers responded to a residence where a daughter and a mother were having an argument. The mother left prior to Officers arrival and it was determined that no physical assault had occurred.

08/20/2021 21-7141 Suspicious Circumstances

It was brought to the attention of LVPD that a petition, gathering signatures to put new Medical Marijuana ordinances in place, may have been falsified. Names on the petition were either deceased at the time it was signed, members of the anti-marijuana group, or stated they did not sign the petition. The investigation is on-going.

08/20/2021 21-7144 Liquor Inspection

Officers conducted a liquor inspection at a local restaurant. The manager was evasive and uncooperative. The license was not displayed. They were advised if they were to continue to serve alcohol, they would need to obtain an updated license.

08/20/2021 21-7146 Intimidation and Threats

Officers responded to a local restaurant, where a verbal argument between workers and customers escalated to the point that the customer threatened to kill a worker. The customer was gone upon arrival of Officers. There were no further issues there.

08/20/2021 21-7150 Family Trouble

Officers responded to a report of a possible domestic violence situation. It was determined that no physical assault had occurred. Officers mediated a solution for one party to get their belonging from the home.

08/20/2021 21-7153 Hospice Death

An Officer responded to a call of a hospice death. The Officer inspected the scene, spoke with the attending hospice nurse and the Oakland County Medical Examiner. It was found not to be suspicious and the deceased was released to the family.

08/20/2021 217161 Hit and Run Traffic Crash

An Officer was dispatched to handle a hit and run traffic crash. The identity of the driver who fled the scene was determined by the Officer. He was contacted and agreed to come into LVPD. He did so, and was issued a misdemeanor citation for leaving the scene of an accident and for a civil infraction of failing to stop within assured clear distance ahead.

08/22/2021 21-7180 Felony Arrest Warrant

An Officer picked up a subject from Beverly Hills PD on a LV warrant for MDOP, \$1K-20K. The prisoner was then transported to Berkley PD for processing, and then turned over to Oakland County Jail in Pontiac.

08/22/2021 21-7192 Found Property

While on routine patrol, an Officer located a BMW motorcycle saddle bag lying in the middle of the street. An owner could not be determined. The bag was placed into property.

08/25/2021 21-2720 No Operators License Arrest

An Officer initiated a traffic stop for a red-light violation. It was determined that the driver did not have a license. He was issued a misdemeanor citation for No Op's Ever Acquired and released on scene. The vehicle was turned over to a licensed driver.

08/25/2021 21-7272 Reckless Driving

While an Officer was attempting to make a traffic stop for a stop sign violation, the vehicle being pursued ran two additional red lights. The driver eventually stopped. The driver was cited for Reckless Driving and the vehicle was impounded.

08/25/2021 21-7293 DWLS / Unregistered vehicle

An Officer conducted a traffic stop for a no plate violation. It was found that the driver was suspended and that the vehicle was unregistered. The driver produced a title which did not match the vin on the vehicle. The vehicle was impounded and the driver was given a misdemeanor citation for DWLS and released on scene.

## 08/26/2021 21-7300 Possession of Methamphetamines / PWID

An Officer initiated a traffic stop for a traffic violation. The driver was found to be suspended and issued a misdemeanor citation for the same. The driver and passengers were released on scene. While the vehicle was being searched for impound, Officers located, individually wrapped, non-descript, packages of marijuana with a scale, and Methamphetamine pills.

### 08/27/2021 21-7343 DWLS Arrest

An Officer responded to take an accident report. While investigating the accident, it was revealed that one of the drivers had a suspended drivers license. He was cited for the same, and released at the scene, per new state law.

#### 08/28/2021 21-7361 Civil Matter

A resident came into LVPD for a documentation purposes only report, indicating that his wife is threatening him saying she would have him kicked out of the home. They were advised how the eviction process works.

## 08/31/2021 21-7431 Stolen Vehicle / DWLS Arrest

Officers stopped a vehicle for a red-light traffic violation. Upon further investigation, the driver had a suspended license and the vehicle had a dealer plate and a dealer sales sheet still inside the vehicle. The driver was given a misdemeanor citation for DWLS and the vehicle was impounded for further investigation. It was found that the vehicle was stolen off of a car dealership lot in Novi the previous day. LVPD is working with Novi PD for possible additional charges.
