

## **City of Lathrup Village Police Department - Monthly Activity Summary**

### **May 2023**

05/01/2023    23-6437        Impounded Vehicle

An Officer observed a vehicle remained stationary in a parking lot for several days. The vehicle was tagged with a 48-hour sticker. The Officer Checked back and the vehicle was still left abandoned. The vehicle was impounded.

05/01/2023    23-6453        Driving While License Suspended

An Officer stopped a vehicle for disobeying a stop sign. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and Disobey Stop Sign. The vehicle was impounded.

05/02/2023    23-6463        Driving While License Suspended

An Officer stopped a vehicle for an equipment violation. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and defective equipment. The vehicle was not impounded due to weather conditions.

05/02/2023    23-6498        Suspicious Activity

An Officer took a report involving City Hall receiving an anonymous letter alleging a Dentist involved in misconduct. There was nothing substantiated in the letters that would require a criminal investigation. It must be noted the same dentist had recently fired a few employees for theft.

05/03/2023    23-6536        Hospice Death

An Officer was dispatched to a residence regarding a Hospice Death. During the investigation, it was determined there were no signs of foul play, the individual was pronounced deceased by a medical professional, and the deceased was released to the family funeral home of their choice.

05/03/2023 23-6544 Vehicle Lockout/Citizen Assist

An Officer was dispatched to a local business to assist a citizen who locked their keys in their vehicle. The Officer had the vehicle owner sign the LVPD Waiver and made entry into the vehicle.

05/03/2023 23-6553 Fleeing/Eluding Police

An Officer attempted to stop a vehicle for improper lane use. The driver of the vehicle failed to stop for the police lights and siren. A very short pursuit ensued and the Officer terminated the pursuit for safety reasons. There are no suspects at this time.

05/04/2023 23-6570 Domestic Violence

Officer's were dispatched to a residence regarding a domestic violence. It was determined that an argument occurred between a boyfriend/girlfriend. The argument became heated and the boyfriend struck the girlfriend several times causing injuries. Medical attention was offered, a report was taken, and no arrest was made because the suspect left prior to police arrival. The case has been forwarded to the Detective Bureau.

05/05/2023 23-6606 Driving While License Suspended/Warrant Arrest

An Officer stopped a vehicle for speeding and disobeying a stop sign. During the traffic stop it was discovered the driver had a suspended driver license and a warrant out of Ferndale PD. The driver was issued a violation for DWLS and Disobeying a Stop Sign. The driver was arrested and turned over to Ferndale PD. The vehicle was impounded.

05/05/2023 23-6642 Identity Theft

An Officer was dispatched to the police station in reference to an identity theft. It was determined that an individual had used the victim's information to write a check for \$910 and cashed the check at a bank in a different city. The case was turned over to the detective bureau for further investigation.

05/05/2023 23-6644 Road Rage

An Officer was dispatched to an intersection regarding a road rage resulting in a collision. It was determined that two vehicles were engaged in a road rage incident resulting in a crash. There were no witnesses and both drivers had conflicting stories. The case has been turned over to the Detective Bureau for further investigation.

05/05/2023 23-6653 Open Intoxicants/Motor Vehicle

An Officer stopped a vehicle for disobeying a red light and speeding. During the traffic stop an open container of alcohol was observed. A Driving While Intoxicated investigation was conducted. The driver was not intoxicated. The driver was issued a violation for disobeying a traffic signal and Open Intoxicants in a motor vehicle.

05/05/2023 23-6657 Driving While License Suspended

An Officer stopped a vehicle for no license plate. During the traffic stop it was discovered the driver had a suspended driver license and a child in the vehicle was not restrained. The driver was issued a violation for DWLS and Child Safety Seat Violation. The vehicle was impounded.

An Officer stopped a vehicle for disobeying a red light. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and a warning for Disobeying the Red Light. The vehicle was turned over to a licensed passenger.

An Officer stopped a vehicle for disobeying a stop sign. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and Disobey Stop Sign. The vehicle was impounded.

05/07/2023 23-6794 Malicious Destruction of Property (MDOP)

An Officer was dispatched to a business regarding a MDOP vehicle. It was determined that the victim's boyfriend came to the victim's place of employment. When the victim refused to speak with him, he repeatedly kicked the victim's vehicle and left the location. The case has been turned over to the Detective Bureau for prosecution.

05/08/2023 23-6805 Driving While License Suspended

An Officer stopped a vehicle for an expired license plate. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and expired plates. The vehicle was impounded.

05/08/2023 23-6833 Suspicious Circumstances

An Officer was contacted while on patrol by a resident wishing to report a suspicious circumstance. It was determined that the resident recently had their vehicle stolen, was paid out by the insurance company, and was contacted over the internet by an unknown party stating the victim received their check. The report was for documentation purposes as no crime occurred.

05/09/2023 23-6903 Misdemeanor Warrant Arrest

An Officer was dispatched to meet Novi Police regarding a subject wanted for a misdemeanor warrant out of Lathrup Village. The Officer met Novi Police, took custody of the individual, processed the individual, and lodged the individual pending 46<sup>th</sup> District Court adjudication.

05/10/2023 23-6919 Suspicious Person

An Officer was on patrol and observed a subject matching the description of a subject who was looking into closed businesses. It was determined that the subject may be a suspect in the recent larceny from vehicles, the subject was identified, and prior to arrest the subject fled from the officers on foot and was able to evade arrest. The case has been turned over to the Detective Bureau for investigation.

An Officer was dispatched to a residence regarding a Larceny from Auto. It was determined during the night that an unknown person entered an unlocked vehicle and took a brief case. The items recovered from 23-6919 are a possible match. The Detective Bureau will investigate.

An Officer was dispatched to a business regarding two subjects arguing. It was determined that the two subjects were involved in a domestic relationship and were arguing in public. There was no evidence or claims of assault and the situation was deescalated by the Officer.

05/11/2023 23-6998 Recovered Stolen License Plate

An Officer was on patrol and observed a vehicle with a license plate in the window. The Officer checked the vehicle in LEIN and determined the license plate was stolen. The vehicle was impounded and the license plate was confiscated. There are no suspects or witnesses at this time.

05/13/2023 23-7120 Child Custody Issue

An Officer responded to the police station to speak with an individual regarding child custody. It was determined that the mother and father of a child had a violation of a custody order. As this is a civil issue, a report was generated for information purposes only.

05/13/2023 23-7139 Family Trouble/Warrant Arrest

Officers were dispatched to a residence regarding a family trouble/domestic situation. It was determined that a verbal argument occurred between a mother and father regarding child custody. It was also determined that one of the parties had several warrants; including a misdemeanor warrant out of Lathrup Village. The subject was arrested, processed, and jailed pending 46<sup>th</sup> District Court adjudication.

05/15/2023 23-7196 MDOP/Attempted UDAA

An Officer was dispatched to a residence regarding a MDOP. It was determined that the homeowner heard a noise and checked on his vehicle. When checking his vehicle, he observed two males running from the vehicle and the driver's side door window was broken.

05/15/2023 23-7208 Family Trouble

An Officer was dispatched to the police station to speak with a resident about a family trouble. It was determined that two sisters are currently arguing about how their mothers ring doorbell was damaged. The resident wanted a report for documentation purposes.

05/16/2023 23-7284 Misdemeanor Warrant Arrest/DWLS

An Officer stopped a vehicle for driving with no headlights. During the traffic stop it was discovered the driver had a suspended driver license and two misdemeanor warrants out of Southfield PD. The driver was issued a violation for DWLS and Driving Without Headlights and was placed under arrest for the two warrants. The driver was turned over to Southfield PD. The vehicle was turned over to the driver's mother.

An Officer stopped a vehicle for disobeying a traffic signal. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS and Disobey Traffic Signal. The vehicle was turned over to a licensed passenger.

Officers have made several unsuccessful attempts to deliver a letter to a residence regarding their unregistered alarm. The department has been dispatched to many false alarms at this residence. The homeowner was issued a violation for failing to register his alarm system with the police department.

An Officer was dispatched to an intersection regarding a hit and run traffic crash. It was determined one party left the location after the traffic crash without identifying themselves. The Officer followed the trail of vehicle fluids to a home in Southfield. The vehicle was impounded and the case is being investigated.

An Officer stopped a vehicle for an equipment violation. During the traffic stop it was discovered the driver had a suspended driver license and two misdemeanor warrants out of Farmington Hills PD. The Officer identified the home, witnessed the man on the floor in distress, entered the home, and summoned Southfield Life Support for assistance. The injured man was transported to the hospital for treatment.

An Officer was dispatched to a business parking lot in reference to an OWI driver. It was determined that the driver was not intoxicated. It was also determined the vehicle left the roadway due to vehicle equipment issues.

An Officer stopped a vehicle for driving without headlights. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS, No Proof of Insurance, and Driving Without Headlights. The vehicle was not impounded due to a small child in the vehicle.

An Officer was dispatched to an accident. During the accident investigation, it was determined one of the drivers had a suspended driver's license. The driver was issued a violation for DWLS and Improper Lane Usage. The vehicle was impounded.

An Officer stopped a vehicle for an expired license plate. During the traffic stop it was discovered the driver had a suspended driver license. The driver was issued a violation for DWLS, Expired Plates, and No Insurance. The vehicle was impounded.

An Officer was dispatched to a residence regarding a possible fraud complaint. It was determined the homeowner had hired a company to work on his cement. When the work was finished, the contractor and homeowner negotiated a price, but the job wasn't finished. A report was taken for documentation purposes.

An Officer was assisting a stranded motorist. When identifying the driver, it was discovered the driver had a suspended driver's license. The driver was issued a violation for DWLS and advised she couldn't driver her vehicle from a parking lot once it was repaired.
