12/02/2022 22-14195 Fraud Report

A report was taken from a resident when they discovered that someone opened an account in their name and charged \$910. The account was closed and the credit agency is investigating.

12/03/2022 22-14220 DWLS Arrest

An Officer initiated a traffic stop when the officer observed a vehicle use private property to avoid a traffic light. It was determined that the driver had a suspended driver's license. The driver was cited and released on scene with a misdemeanor citation for DWLS. The vehicle was impounded.

12/03/2022 22-14254 DWLS Arrest

An Officer initiated a traffic stop when the officer observed a vehicle fail to stop at a stop sign. It was determined that the driver had a suspended driver's license. The driver was cited and released on scene with a misdemeanor citation for DWLS and a civil infraction for Fail to Stop at a Stop Sign. The vehicle was impounded.

12/05/2022 22-1317 DWLS Arrest

An Officer initiated a traffic stop when the officer observed a vehicle make a prohibited left turn. It was determined that the driver had a revoked driver's license. The driver was cited and released on scene with a misdemeanor citation for DWLS and Prohibited Turn. The vehicle was impounded.

12/06/2022 22-14361 Felony Warrant Arrest

An Officer initiated a traffic stop for a vehicle that made a Prohibited Turn. It was determined that the driver had an outstanding warrant out of Birmingham. The driver was turned over to a Birmingham Police Officer. The vehicle was turned over to a licensed passenger.

12/06/2022 22-14359 Flee and Elude Officer

An Officer responded to an accident investigation. Upon the Officers arrival, the driver of one of the vehicles involved in the accident fled the scene and was pursued by the Officer. The fleeing vehicle crashed and the driver fled on foot. The Officer pursued the driver on foot and arrested the driver without incident. The driver was arrested, lodged, and is awaiting charges from the Oakland County Prosecutors Office.

12/06/2022 22-14360 Larceny From Vehicle

An Officer responded to a business when it was reported that someone had broken their vehicle window and taken their vehicle radio. The Officer investigated the scene and provided the victim with a case number to follow up with their auto insurance company.

12/06/2022 22-14364 Driver's License Never Acquired

An Officer initiated a traffic stop when the Officer observed a vehicle fail to stop at a stop sign. It was determined that the driver had never had a driver's license. The driver was cited and released on scene with a misdemeanor citation for No Operators License Acquired and a civil infraction for Fail to Stop at a Stop Sign. The vehicle was impounded.

12/07/2022 22-14391 Recovered Stolen Vehicle

A citizen reported her vehicle stolen from a domestic situation in Southfield earlier in the day. An Officer verified that the vehicle was returned to the owner and notified Southfield to remove the vehicle from the LEIN System.

12/07/2022 22-14392 Personal Protection Order Violation

An Officer investigated a violation of a personal protection order referencing child custody. It was determined that the personal protection order was not served. The Officer served the personal protection order and the State of Michigan was notified.

12/07/2022 22-14396 Customer Trouble

An Officer was called to a business in reference to a customer trouble. An Officer investigated the situation and it was determined it was a civil issue between two individuals regarding a real estate transaction in Wayne County. One subject was advised on trespassing and left location.

12/07/2022 22-14401 Intimidation Report

An Officer was called to a business because a customer was agitated and threatened to shoot the business employee. The customer left prior to the Officer's arrival. The same customer also called later and made the same threat. A report was generated and forwarded to the Detective Bureau for further investigation.

12/07/2022 22-14404 Assist Other Department- Armed Robbery

An Officer heard over the police radio that an armed robbery occurred at a Southfield business. The Officer located the suspect vehicle in Lathrup Village. The Officer, assisted by Southfield PD, conducted a felony stop, took the subjects in custody, and the scene/vehicle/subjects were turned over to Southfield PD for prosecution.

12/09/2022 22-14478 Operating While Impaired

An Officer initiated a traffic stop for a vehicle that made a prohibited turn. It was determined that the driver was intoxicated and an OWI investigation was conducted. The driver was arrested for OWI, booked, refused the Breathalyzer, and a search warrant for blood was obtained. The vehicle was impounded and the case is pending the blood results from the Michigan State Police Crime Laboratory.

12/10/2022 22-14493 Suspicious Person

An Officer was called to a resident's home regarding a subject looking into their parked vehicle. The Officer investigated, determined the vehicle was not damaged or entered, and checked the area for the subject. There are no investigative leads at this time.

12/10/2022 22-14511 Larceny From Auto- Unlocked Vehicle

An Officer was called to a resident's home regarding a larceny from vehicle that was parked in their driveway. It was determined that the suspect entered the unlocked vehicle and stole a small amount of cash and a cell phone charger. There was no vehicle damage. There are no investigative leads at this time.

12/10/2022 22-14513 Larceny From Auto (attempted) - Unlocked Vehicle

An Officer was called to a resident's home regarding an attempted larceny from a vehicle that was parked in their driveway. It was determined that the suspect entered the unlocked vehicle and rummaged around. Nothing was taken and there was no vehicle damage. There are no investigative leads at this time.

12/10/2022 22-14533 Assist Citizen/Lock Out

An Officer was called to a resident's home regarding keys locked inside a vehicle. The Officer gained access to the resident's vehicle.

12/12/2022 22-14608 Fraud

Officers responded to a business on a report of a subject using false identification to make a bank withdrawal. An Officer arrived and located the subject in question. It was determined that the subject used the identity of another person and was arrested for Fraud/Identity Theft. The case was turned over to the Detective Bureau for prosecution.

12/12/2022 22-14609 Phone Harassment

An Officer was called to a residence because an ex-boyfriend was sending threatening texts to kill the resident. A police report was taken and forwarded to the Detective Bureau for further investigation. The resident was provided Personal Protection Order information.

12/12/2022 22-14610 Larceny From Auto (attempted) - Unlocked Vehicle

An Officer was called to a resident's home regarding an attempted larceny from a vehicle that was parked in their driveway. It was determined that the suspect entered the unlocked vehicle and rummaged around. Nothing was taken and there was no vehicle damage. There are no investigative leads at this time.

12/12/2022 22-14635 Misdemeanor Warrant Arrest

An Officer met Franklin/Bingham Farms PD and took custody of a subject who had an outstanding warrant out of Lathrup Village. The subject was transported to Berkley PD and processed. The subject posted bond and was released.

12/13/2022 22-14660 DWLS Arrest

An Officer initiated a traffic stop when the officer observed a vehicle fail to stop at a stop sign. It was determined that the driver had a suspended driver's license. It was also determined the vehicle plates were expired. The driver was cited and released on scene with a misdemeanor citation for DWLS and a civil infraction for expired plates. The vehicle was impounded.

12/14/2022 22-14697 Driver's License Never Acquired

An Officer was conducting radar enforcement and observed a vehicle speeding. The Officer initiated a traffic stop. It was determined that the driver had never had a driver's license. The driver was cited and released on scene with a misdemeanor citation for No Operators License Acquired and a civil infraction for Speeding. The vehicle was impounded.

12/15/2022 22-14759 Larceny (Felony)

An Officer was called to a business regarding a larceny of a parcel package containing a computer. It was determined that the suspect entered the business, misrepresented herself, and claimed a package belonging to another person. A report was taken and the case has been turned over to the Detective Bureau for further investigation.

12/19/2022 22-14865 Flee and Elude Officer

An Officer observed a vehicle make an illegal U-turn on Southfield/Ramsgate. The Officer activated the patrol vehicles lights and siren. The Officer pursued the suspect vehicle until the pursuit was terminated on Southfield/Lincoln. The suspect vehicle continued Southbound Southfield at approximately 80-90 miles per hour. The vehicle and driver were not identified.

12/19/2022 22-14878 Customer Trouble

An Officer was called to a business in reference to a customer trouble. An Officer investigated the situation and it was determined, per the business manager, the customer was no longer allowed on the premises. The Officer advised the customer regarding trespassing and the customer left the location without incident.

12/19/2022 22-14880 Misdemeanor Warrant Arrest

An Officer initiated a traffic stop for a vehicle that was speeding. It was determined that the driver had an outstanding warrant out of Lathrup Village. The driver posted the bond and was released with court information at the scene of the traffic stop.

12/20/2022 22-14922 Civil Issue

An Officer was called to a residence in reference to a civil issue. An Officer investigated the situation and it was determined the complaint was indeed a civil issue and wrote a report for the resident to document the situation (homeowner vs hired worker dispute).

12/20/2022 22-14940 Misdemeanor Warrant Arrest

An Officer was dispatched to meet Farmington Hills PD for a subject who is wanted for a Lathrup Village Misdemeanor Warrant. The Officer met the Farmington Hills Officer, took custody of the person, booked the person, completed the bond posting process, and released the person with court/bond information.

12/22/2022 22-15015 Hospice Death

An Officer was dispatched to a residence in reference to a Hospice Death. The Officer investigated the death, determined there was no foul play, and the person had an extensive medical illness history. The Oakland County Medical Examiner Investigator was contacted and she released the deceased to the family/funeral home.

12/24/2022 22-15079 Dog Bite (Attempted)

An Officer was called to a residence regarding a dog bite that occurred. The Officer investigated the incident and determined that a homeowner's dog had escaped from its collar and charged at another resident who was walking their dog. The charging dog attempted to bite the other resident and their dog. No injuries occurred and a report was generated to document the event.

12/26/2022 22-15151 Family Trouble

Officer's were dispatched to a residence regarding a family trouble. Officers investigated and determined the issue between father and son was a civil issue (eviction process). There was no evidence of an assault. A report was generated to document the event.

12/27/2022 22-15169 Damage to Lawn

An Officer was called to a residence regarding a vehicle that had driven across their front lawn. The Officer investigated and it was determined that due to the ice/snow on the road an unknown vehicle had slid off the road and onto the resident's lawn.

12/28/2022 22-15215 Hospice Death

An Officer was dispatched to a residence in reference to a Hospice Death. The Officer investigated the death, determined there was no foul play, and the person had an extensive medical illness history. The Oakland County Medical Examiner Investigator was contacted and the deceased was released to the family/funeral home.

12/28/2022 22-15220 DWLS/Obstruct Police Arrest

An Officer initiated a traffic stop when the Officer observed a vehicle make a prohibited turn. It was determined that the driver had a suspended driver's license, provided a false name, and had a felony warrant out of Southfield. The driver was having a medical episode, refused medical attention, and was cited and released. Due to the medical condition, Southfield did not wish to enforce the warrant. The sober/licensed passenger took possession of the vehicle.

12/28/2022 22-15223 Civil Issue

An Officer was called to a residence in reference to a civil issue. An Officer investigated the situation and it was determined the complaint was indeed a civil issue and wrote a report for the resident to document the situation (homeowner vs company- missing item ordered dispute).

12/28/2022 22-15231 Felony Warrant- Carrying a Concealed Weapon

An Officer initiated a traffic stop for a vehicle that failed to stop at a stop sign. It was determined that the driver had an outstanding warrant out of Detroit for Carrying a Concealed Weapon. The driver was arrested and turned over to a Detroit Officer. The vehicle was turned over to a licensed passenger.

12/29/2022 22-15273 Larceny From Auto- Unlocked Vehicle

An Officer was called to a resident's home regarding a larceny from vehicle that was parked in their driveway. It was determined that the suspect entered the unlocked vehicle and stole a Taurus 9mm Pistol from the glove box. The gun was registered as stolen in LEIN. There was no vehicle damage. There are no investigative leads at this time.

12/29/2022 22-15278 DWLS Arrest

An Officer initiated a traffic stop when the Officer observed a vehicle speeding. It was determined that the vehicles license plate was deemed fraudulent by Michigan Secretary of State. The driver was cited, the license plate was confiscated/destroyed, and the driver was released on scene. The vehicle was not impounded and the Officer allowed the vehicle to be parked off the roadway.

12/30/2022 22-15291 Civil Issue

An Officer was called to a residence in reference to a civil issue. An Officer investigated the situation and it was determined the complaint was indeed a civil issue and wrote a report for the resident to document the situation (homeowner-company-phone issue).

12/30/2022 22-15319 Felony Warrant Arrest

An Officer initiated a traffic stop for a vehicle that had no rear functioning lights. It was determined that the passenger had an outstanding warrant out of Southfield. The passenger was turned over to a Southfield Officer. The driver was released with the vehicle at the traffic stop scene.
