

The exterior of the front of the building will undergo an enhanced design to elevate both aesthetics and visual appeal. The existing façade will be resurfaced with a 3' stone wall, to provide a contemporary and polished appearance. The 3 columns will also be wrapped with stone and lighting will be added to each of the columns. Additionally, signage with the building's name and services will be added and lit above the awning to be visible at night.
