In addition, a discussion relating to presenting the items the Planning Commission on Monday, July 6, 2026, public hearing may not be necessary. I will confirm the validity of the statement at the conclusion of the Work Session. Results will be published tomorrow morning.

Items 1, 2, and 3 on the agenda are expected to be tabled at the outset of the Planning Commission Work Session and the subsequent regular meetings scheduled for Wednesday, June 10, 2026, and Monday, June 22, 2026, respectively.

Item 1 was advertised without all pertinent information, and additional details are needed to ensure the public notice accurately reflects the nature of the request. Items 2 and 3, both of which are zoning applications, cannot proceed at this time because the subject properties are less than five acres in size. As a result, a text amendment to the Zoning Ordinance will be required prior to further consideration of these requests.
