Subject: Department Report – July 2025

Accounts Payable

o Payments made in July 2025; 241 checks were processed for payments of \$2,150,421.64.

Audit

- Auditors were present for the interim field audit on August 15-16, 2024.
- Auditors were present October 21-25, 2024 for the final field audit. Staff had a few items left to address, specifically capital assets, outstanding accounts payable, and some questions sent by auditors. Staff wrapped up all remaining items quickly to ensure a timely delivery of the audit report.
- City received draft financial statements on June 27.
- Staff has been working with the audit firm to finalize the financial report. As of the writing of this
 report, staff is still waiting for the firm to produce the final document.

Payroll

 Payroll was processed on July 3rd and July 18th for all employees. In total, 123 employees were paid in July.

Utility Billing

- 6,336 billing statements (including electronics) were mailed July 30th for a total of \$1,338,558.80 in utility revenue and \$166,475.40 in city service fee revenue.
- On July 17th, 195 phone calls went out to notify customers they have a past due balance.
- There was a total of 83 lockouts in July.
- There was a total of 325 service requests in July: 67 move ins, 83 lock-offs, 11 re-read meters, 58 reconnects, 41 move outs, 6 leak checks, 16 changed meters, 31 turn ons, 7 turn offs, 2 meter installations, no meter removals, no dead meters, no water quality checks, 1 pressure test, no emergency requests, no meter tests, 1 meter locate, and 1 miscellaneous request.
