Subject: June Monthly Report

- For June 2025, the Patrol Division had approximately 1,620 calls for service, made 106 arrests, conducted 290 traffic stops, and wrote 160 case reports.
- Trainee Adam Hobbs officially resigned his position as Police Officer.
- We currently have one opening for a Communication Specialist and three openings for Police Officer.
- We recently interviewed a total of five certified police officers and have moved three into the background phase.
- We conducted testing for our vacant Communication Specialist position, but unfortunately, we will not be moving forward with those who tested. We have re-opened this position.
- The Detective's Division is still busy with involved cases. This month, they were assigned one (1) new case. They were able to close three (3) cases and aided in training off Staff reviewed approximately fifty (50) incoming child abuse referrals from DHS.
- As we move closer to being fully staffed, Officer Tyler Romeo has been assigned to the Detective Unit from the Patrol Division. This brings our Detective Unit back to full-staff and allows one detective to work full-time on the combined agency drug team (LINE), enabling a more focused approach in the Lebanon area. Officer Alan Baker is now assigned to a schedule dedicated to working traffic enforcement.
- Community Services staff members Albanese and Johnson, along with members of the patrol teams, continue to conduct extra patrols within our parks system to assist in reducing unwanted activities (ordinance violations and trespassing) and provide outreach. A focus has been placed on all parks, especially Ralston Park, with a zero-tolerance approach in place to help curb unruly behavior. This month, both attended a two-day training to enhance response strategies and community support resources. They also patrolled all city parks, trespassed Six (6) individuals for City ordinance violations. Staff also aided mental health/crises team members and gave out several resource guides to those in need.
- A Neighborhood watch meeting was conducted on West Grant Street to set up a new group. New signage has been placed to help promote safety and visibility.

- We had twenty-two (22) children take part in our annual Cast with a Cop event where they fished with Officers from Lebanon Police Department and Linn County Sheriffs Office.
- Officer Zac McKinney will be recognized and awarded the Lebanon Police Life Saving award for his quick response to a call of an overdose on June 10th, 2025. Due to Officer McKinney's quick actions, CPR and overall composure, and decisive action, the subject made a full recovery.
- There was two (2) use-of-force incidents for June. (1) Officers were taking a subject into custody for a domestic assault and the subject pulled away after he was placed in handcuffs. The subject continued to pull away from officers and refused to get into the backseat of a patrol vehicle on his own. The officer turned the subject and used his body weight to push the subject onto the ground. Officers were then able to control the subject and get him into the patrol vehicle. No injuries to wither the subject or officers. (2) Officer was conducting an roadside field sobriety test on a suspected drunk driver. During the test, the subject attempted to run from officers. Officers were able to grab onto the subject's body and pulled him to the ground. The subject continued to resist and refused commands to put his hands behind his back as the subject tried to reach for his waist area. Officers were finally able to gain control of the subject, and the subject was then taken into custody. One officer sustained a bloody nose due to being hit in the face by the subject's head while he resisted. Another officer was hit in the face by the subject while he resisted but sustained only minor injury. All use-of-force incidents are reviewed extensively by a Sergeant, a Lieutenant, the Police Captain, and finally the Chief. All use-of-force incidents were found to be justified and fell within policy standards.

- There was (1) use-of-force incident for May. An officer observed a subject on a bicycle who had multiple warrants; upon contact, the subject fled through a field. The officer pointed his Taser at the subject, gave verbal commands, and the subject complied and was taken into custody with no further incident. All use-of-force incidents are reviewed extensively by a Sergeant, a Lieutenant, the Police Captain, and finally the Chief. All use-of-force incidents were found to be justified and fell within policy standards.
- We had one incident of successful NARCAN deployment this month. Officers responded to an unconscious male subject in a vehicle. The male was removed from the car and had three doses of NARCAN administered. Medics responded and transported the subject to Linn County Hospital, where he made a full recovery.
